Subject: Request for Registration of FIR

Respected Sir/Madam,

I, Smt. Mary Margaret Chacko, daughter of Late K.T. Chacko and wife of Sri Debarshi Roy, presently residing at Salbari, P.S. Pradhan Nagar, District Darjeeling, and formerly residing at Hansqua, Dulurchhat, P.O. Now Bagdogra, P.S. Phansidewa, District Darjeeling, would like to lodge the following complaint for your immediate attention and necessary legal action:

1. That I am one of the legal heirs of my late father Kathirankal Teressamma Chacko @ K.T. Chacko and my late mother Smt. Teresa Soren Chacko.
2. That my deceased mother was the recorded owner of more than 600 decimals of land in Mouza Dulurchhat, comprising various plots under Khatian Nos. 25, 27/2, 74/1, and 27/1.
3. That my mother was a well-educated individual, serving as a teacher in a reputed institution. Since around 2012, she suffered from multiple health issues, including neurological ailments, for which she was admitted to Anandaloke Hospital, and subsequently to other medical facilities. Her condition progressively deteriorated, and she was medically and mentally impaired in her final years until her death in 2019.
4. That my mother belonged to a Scheduled Tribe (ST) community, whereas my father did not belong, into any Scheduled Tribe. As such, the land owned or inherited by my mother shall legally be treated as tribal land, and no transfer or alienation of the said land is legally permissible without the prior written approval of the competent authority, as mandated under applicable tribal land protection laws.
5. That I have one full-blooded brother from the said wedlock, namely Mr. Sebastian Chacko @ Chacko Sebastian, residing at Hansqua, Dulurchhat, District Darjeeling.
