Respected Sir,

In producing herewith one arrested person namely Pramik Roy (29 years) S/O Lt Kartik Roy of Saipatri Road, Bhupendra Nagar, near Sporting Club, Ward No. 42, PS Bhaktinagar, Dist Jalpaiguri along with the following seized articles under seizure as per seizure list:

1. Forty (40) bottles of Codeine Phosphate & Triprolidine Hydrochloride Cough syrup style as REXLEY-T having having Batch No. MLS25319; Mfg Date. 05/25; Exp. Date: 04/27 Mrp Rs. 175 Rs each, 100 ml each which is marked as exhibit A.
2. One silver colored Scooty style as "DIO" Company Honda having registration no WB 74 AY 7274.
3. One Silver Color key pad mobile style as "NOKIA"
4. One Blue Color mobile phone style as Vivo Y33S having IMEI no 891297055671331/00, 861297057671323/00

• The above noted cough syrups were kept inside the Scooty bearing No. WB 74 AY 7274 which was in the possession of Pramik Roy.

I, SI Abhishek Theengh S/O Suchandra Kumar Theengh of Bhaktinagar PS under Siliguri Police Commissionerate do hereby lodged this written complaint against above mentioned accused persons to the effect that on 09.08.2025 at about 16.40hrs, I received secret source information that an individual is coming from the Ashigarh area on a Scooty having registration no WB 74 AY 7274, with strong reason to believe that he is in possession of a large quantity of contraband substances. The matter was diarized in Bhaktinagar PS vide Bhaktinagar PS GDE No. 419/25 dated 09.08.2025.

Subsequently, I informed the matter in written to the I/C Bhaktinagar PS, SPC and being directed, at about 16.55hrs I along with SI Srimanta Chatterjee, ASI Dhurba Mishra, ASI Khagen Barman, ASI Dipak Karmakar and Const/374 Debraj Biswas left PS by Govt. hired vehicle to verify the veracity of the information. This refers to Bhaktinagar PS GDE no. 420/25 dated 09.08.2025 and M.C.C No-3867/25 Dated 09.08.2025

Under this circumstance any search warrant or authorization cannot be obtained without affording opportunity for the concealment of evidence or facility for the escape of the offender.

Thereafter, at about 17.20hrs, we reached Eastern bypass in front of Pritam Motors, under Bhaktinagar PS, and after arriving there, I found the public there at the spot, and I tried to convince them to accompany us. The following persons, namely 1) Chandan Kumar Dubey (30 years) S/O Hare Ram Dubey of Medical more, Kawakhali, PS Matigara, Dist Darjeeling. 2) Md Appu (26 years) S/O Mustakin of Asraf Nagar, PS Bhaktinagar Dist Jalpaiguri came forward to accompany us to work out the information. Thereafter I informed them about the information in hand and requested them in writing to accompany us in the whole process during search and seizure, if any and they gave in writing about their approval to accompany Police during raid, search and seizure.

Being indicated by my source we detained one scooter bearing registration no WB 74 AY 7274 in front of Pritam Motors, Eastern By pass road, which was coming from Ashigarh area and thereafter we disclosed our identity and the information in hand and stated him that he will be searched in persons and as well as his scooter for the purpose. At this, he disclosed his name and address as noted above. Further he confessed that he has possessed the illegal syrup for supplying the same to his designed customers as per requirement.

Subsequently, I then gave him option whether he wanted to be searched in presence of the special Executive Magistrate or by any Gazetted Officer. Then he agreed to be searched by one of them. Further I served a notice in accordance with provisions of law in this regards.

After verifying the information I contacted to Shri Samrat Mitra Inspector In-Charge, Bhaktinagar Police Station to come at eastern bypass under Bhaktinagar PS, requested him to present during search and seizure. At 17.45 hrs Shri Samrat Mitra, Inspector In-Charge, Bhaktinagar Police Station arrived at the spot as Gazette Police Officer and under his supervision and in presence of independent witnesses the process of search of the detained person was conducted and recovered the above noted articles.

Subsequently, being demanded in presence of Shri Samrat Mitra Inspector In-Charge, Gazette Police Officer the detained person failed to produce any valid document in support of aforesaid recovered syrup.

I seized the above noted articles at the spot under proper seizure list duly signed by the independent witnesses, I also labeled and sealed the same, the entire search and Seizure was conducted under the supervision of Shri Samrat Mitra, Inspector In-Charge of Bhaktinagar PS. The whole process of search & seizure has been captured in audio & VDO graphed. The whole process of seizure was made in between 09.08.2025 in between 17.55 hrs to 18.35 hrs.

Being further asked, the apprehend person admitted in presence of Shri Samrat Mitra,, Inspector In-Charge of Bhaktinagar PS and other independent witnesses that he procured the syrups clandestinely from elsewhere for the purpose of selling the same in high rate to his designed customer for personal gain by illegal means also disclosed that he has been dealing in such business of procuring and selling of syrups illegally for last few months.

Then, I arrested the above noted accused person namely Pramik Roy (29 years) S/O Lt Kartik Roy of Saipatri Road, Bhupendra Nagar, near Sporting Club, Ward No. 42, PS Bhaktinagar, Dist Jalpaiguri at 18.37 hrs after observing all formalities and informing the ground of arrest and issued necessary Memo of Arrest u/s 35 of BNSS.

Under the above circumstances, I pray to you that a specific case under proper section of law may kindly be started against the accused person namely Pramik Roy (29 years) S/O Lt Kartik Roy of Saipatri Road, Bhupendra Nagar, near Sporting Club, Ward No. 42, PS Bhaktinagar, Dist Jalpaiguri and arrange for its investigation.
