I Archana Singh, the above noted Complainant
beg to inform you that on Dt. 09.08.2025 at

when I protested, they started beating me brutally
with fist & blows and threatened me for doing
consequences, it was with me and my husband
namely, Rajesh Singh s/o Lt. Mahadeb Singh, and my
son namely Surej Singh s/o Sri Surej Singh and
my daughter namely, Sapna Saha s/o Sri Pulash
Saha, of Mathabanga, Paschim Para, Distt -
Coochbehar, will not leave our home.

Sir, it is pertinent to say that nearly 2 1/2
months ago, they lodged F.I.R. against us and
my husband namely, Rajesh Singh and my son
namely, Surej Singh, were arrested and were in
Jail, even though they are not allowing them to
enter into my house.

The above noted alleged persons are very
desperate & dangerous in nature and they
want to evict from our home and capture
our property.

So, please take necessary action against
the above noted alleged persons.
