I, Sagar Subba, Store Manager of iDestiny (CCSGE0015 – City Center Mall | Uttorayon Township, Siliguri 734010), would like to lodge an official complaint regarding a theft incident that occurred in our store on 09.08.2025.

At approximately 7:27 PM, a male individual entered our store and forcibly removed the adhesive alarm cable from an iPhone 16 Pro Max, 256 GB, Black Titanium kept on the demo display table. The person then left the device on the stand for a while, apparently to divert the attention of our sales staff.

At around 7:44 PM, the same person returned to the display table, picked up the said device, concealed it in his pocket, and left the store premises without making payment.

The entire incident has been captured in our store's CCTV footage, we have enclosed pen drive with CCTV footage for your reference.

We request you to kindly register this complaint as an FIR and take necessary action to identify and apprehend the accused and recover the stolen device.
