

Received on 10.08.25 at 20:15 has vide GDE NO. 536 and started Maligare P\$ case NO. 515 [25 Dtd. 10.08.25 ups 3/4/7/8 of Immoral Graffic (Procention) Act. Inspector Kajal Barkar of D.D. I SPE will investigate the Case as per order

I, SI Biswajit Ghosh of Detective Department, Siliguri Police Commissionerate Police Statio do hereby lodge this written complaint against the 02 (two) arrested accused persons namely (i) Vibek Kumar Mahato (M/32) S/O Satyendra Mahato of Champasari Samar Nagar, PO + PS- Pradhannagar, Dist- Darjeeling and (ii) Akriti Gurung @ Prasana (F/22) D/O Late Dipendra Gurung of Ava Art Gallery, Near Gyanoday Niketan, PS- Sadar, Dist- Darjeeling to the effect that on 10.08.2025 at 16.05 hrs received a secret information that some prostitution business is going on at different SPAs of City Centre under P.S Matigara under the coverage of body massage. Accordingly, the information was diarized vide D.D SPC GDE No-. 64 Dated 10. 08.2025 . As per order of ACP, DD, SPC, myself along with SI Basudeb Guha, ASI Sushanta Dey, Const. 562 Utpal Saha, Const. 670 Ratan Roy, Const. 686 Arup Saha and LC- 1332 Jayanti Oraon all of DD, SPC left for City centre Vide GDE NO 65 Dt. 10.08.2025 to verify the veracity of information. On arrival at City Centre, I requested available local independent witnesses namely (i) Abhay Kr. Mishra (M/48) (Ph. 8537040094) S/O Lt Ram Ayodhay Mishra of Ghoklajote, PO + PS - Matigara, Dist- Darjeeling and (ii) Ankit Saibo (M/19) (Ph No. 7029590568) S/O Khem Saibo of Khaprail Sainikpuri, PO- New Chamta, PS- Matigara, Dist- Darjeeling to remain present during the time of raid, search and seizure if any. Subsequently, we proceeded into the shop styled as "GLOW" Saloon & Spa at the basement of City Centre and, seeing the Police party some of the people and the lady staffs of the SPA who were outside the shop fled away. Then we entered into the SPA, and found reception counter and one small room of the SPA was closed from inside. Then we opened the room and found accused noted in SI. No (i), and (ii) inside the room in an objectionable position (i.e almost nude) and were involved in sexual activities. We asked them to put on their clothes. With the help of lady Police, the girl was separated from the male accused person.



On interrogation, they disclosed their identity as noted above and the lady accused admitted that she herself running the business of prostitution and earn money by engaging herself in illegal prostitution. She further revealed that she and others were carrying the business of prostitution under the camouflage of Body massage for their monetary benefit and also admitted that they meet up the urged of customers by demanding extra money and provide them sexual favour. Accordingly, we searched the "GLOW" Unisex Saloon in presence of independent witnesses and found (i) One used Condom from the bed of the room and (ii) Two unused Condom from the "GLOW" SPA. Accordingly, I seized the same under proper seizure list in presence of witnesses under proper videography. Subsequently, I arrested accused namely (i) Vibek Kumar Mahato (M/32) S/O Satyendra Mahato of Champasari Samar Nagar, PO + PS- Pradhannagar, Dist-Darjeeling and (ii) Akriti Gurung (F/22) D/O Late Dipendra Gurung of Ava Art Gallery, Near Gyanoday Niketan, PS- Sadar, Dist- Darjeeling u/s 35 of BNSS observing all formalities. The female accused was arrested maintaining all dignity and decency. I also inform them the ground of arrest. The whole process of search, seizure and arrest was done in the presence of Sri Debasish Bose, ACP, DD, SPC. The seizure was made in between 16.45 hrs and 17.15 hrs in presence of witnesses.

Hence, I would like to request you that a specific case under proper sections of law may please be started against (i) Vibek Kumar Mahato (M/32) S/O Satyendra Mahato of Champasari Samar Nagar, PO + PS- Pradhannagar, Dist- Darjeeling and (ii) Akriti Gurung @ Prasana (F/22) D/O Late Dipendra Gurung of Ava Art Gallery, Near Gyanoday Niketan, PS- Sadar, Dist- Darjeeling and others and arrange for its investigation.
