Respected Sir,

I, Shri Ramesh Kumar Agarwal son of late Sankar Lal Agarwal residing at Somani Mill Compound, Station Feeder Road, Siliguri, Post Office & Police Station - Siliguri, Dist-Darjeeling, West Bengal, Pin 734001 state as follows:-

I and my wife alongwith my business partners are joint owners in possession of a 40 (forty) bighas plots situated at mouza – Ranidanga under Gossaipur Gram Panchayet, Police Station – Bagdogra, District – Darjeeling and our said property is situated at Ranidanga, Opposite State Bank of India. Our said property has a private road owned by us leading to it.

On 01/08/2025 at about 1.00 P. M. said Sri Nisith Agarwal son of late Bhojraj Agarwal, resident of Punjabi Para, Siliguri alongwith his unknown associates unlawfully and forcibly entered our above mentioned property in JCB Machine and started damaging the property by breaking and digging parts of the land and structures.

Upon being informed of this trespass and damage, I immediately rushed to the spot and strongly objected. At that time, Sri Nisith Agarwal attacked me with repeated punches. He then forcibly covered my mouth with a cloth and attempted to strangulate me, putting my life in grave danger.

Despite my breathless and defenceless condition, he continued to punch me repeatedly. Thereafter he forcibly snatched my gold bracelet, gold chain, gold ring amounting of rupees more than seven lacs and Rs. 50,000/- (Rupees fifty thousand) only in cash from my pocket.

This entire incident occurred in the presence of several persons and I sustained severe injuries and was immediately taken to a private doctor at Siliguri for medical treatment, who prescribed me complete bed rest as because my condition was very bad due to said attack by said miscreants. The delay in lodging this F.I.R. is solely due to my medical condition, I was unable to move from last eight days due to said injuries, therefore, I was not in a position to lodge this F.I.R. immediate after said incident.

This criminal act amounts to serious offence under the Bharatiya Nyaya Sanhita, 2023 in short B.N.S., including but not limited to section 327, 324, 115, 109, 309, 308, 351 and 3 (5) of The B.N.S.

I therefore, request to kindly register this complaint as an F.I.R. against said Sri Nisith Agarwal and his unknown associates and please to investigate the matter at the earliest and recover my stolen articles and cash from the possession of said Sri Nisith Agarwal and take immediate legal action including arrest of the accused persons as early as possible for the interest of law and justice otherwise I am apprehending that said person may try again to kill me to fulfill his evil desire. I am ready to provide any further information and assistance required during the investigation. Hope, considering the gravity of the offence you will do the needful at an earliest for the ends of justice.
