Respected Sir,

With due regards, I, **SMT.SUCHITA NAGDEOTE**, Wife of Sri **AVISHEK SARKAR**, Daughter of Sri Prakash Nagdeote, resident of Telipara, Primary School Road, Telipara, P.O. Ghogomali, P.S. Bhaktinagar and District: Jalpaiguri, Pin: 734006, would like to lodge this written complaint to the effect that in the year 2019, I met with one Avishek Sarkar who was a personal trainer at Crossfit Gym Fitness Center which is situated at Panitanki More, Sevoke Road, Siliguri. During the course of my personal training at the said Gym, we fell in love and ultimately our marriage was solemnized on 26th day of February 2020, after getting consent from both the families. After my marriage I started to reside at my Matrimonial house at Deshbandhu Para along with my husband and In-Laws.

Sir, after few days of our marriage, I discovered that my husband has been in a long-standing illicit relationship with his elder brother's wife namely Sreetama Sarkar wife of Arijit Sarkar and on being questioned by me about the said matter my husband without giving any explanation started abusing me with filthy languages and even used fist and blows due to which I sustained injuries. Subsequently on 04th April 2020 at about 12 noon when I got an opportunity to have a glance at my husband's phone, to my surprise I found out many obscene photographs of my husband along with the said Sreetama Sarkar in their private moments and when I confronted my husband regarding this, a huge quarrel broke out between us. During the said quarrel I was beaten up by my husband mercilessly and even used filthy languages causing immense mental and physical torture to me.

After the said incident, I narrated the entire facts to my Mother-In-Law namely Sumana Sarkar but she did not protest against the said Illicit relationship nor my other In-Law members did protest for the same. It is only after few days I realized that all the members of my In-Laws were having knowledge about said Illicit relationship. After this incident, I was mentally and physically tortured by my In-Laws whenever I protested against the said relationship. That in the month of

April 2020, I started to live at my father's house along with my husband with the hope to create some distance between my husband and the said Sreetama Sarkar. Even during the stay at my father's house, my husband went missing on 03/06/2020 and finding no other alternative I lodged missing complaint before the Siliguri P.S. on 07/06/2020. Later on my Husband himself surrendered before the Police Station without any explanation about his whereabouts.

After this incident I returned to my Matrimonial house along with my husband. My In-Laws along with husband put tremendous pressure upon me to accept the said illicit relationship. That on 14/03/21 while I was peacefully making my husband understand about his wrong doings, he suddenly became furious and started to hit me with fist and blows and even kicked me. On the other hand, my Brother-In-Law namely, Arijit Sarkar came and pressed my neck and strangled me. In order to save my life, I bit said Arijit Sarkar's hand and on seeing this, my mother-in-law rushed towards me and caught my hair and started to hit me with a slipper repeatedly. Again, in order to save myself I somehow managed to escape from their clutches and ran towards the staircase in order to go out of the house, but said Sreetama Sarkar and her business partner namely Arghya Maitra caught me and tied me with a rope in the staircase so that I do not escape. They all conspired together and took away my mobile phone. I would also like to mention that said Arijit Sarkar's son namely Avilash Sarkar threw kitchen utensils at me when I was tired up with rope and also poured water at me. Hearing all the hues and cries few people from neighbor came and rescued me. Police were informed by my In-laws themselves and they portrayed me as a mentally unfit person. A similar kind of incident happened again on 07/08/2021, when my husband again became furious and started physical torture at me after which I was admitted to Siliguri District Hospital for treatment.

Sir I would like to mention that this is my second marriage and my first marriage being unsuccessful made me bear all form of mental and physical torture by my In-Laws with a hope that someday my Husband would understand his mistake and rectify himself. After going through so much torture and I constantly tried to live separately with my husband so that I may have a happy married life but all my hopes went in vain. Finally on 27th February 2024, I was driven out from Matrimonial house and since then I am living

at my parental house. Many times I have tried to enter matrimonial house but each and every time, I was abused with filthy and derogatory languages and was not even allowed to enter into my matrimonial house. Finally on 24.07.2025 I went to my matrimonial house in order to continue my further conjugal life with my husband but I was restrained and not allowed to enter into the matrimonial house by my husband and my in-laws and was thrown away from my matrimonial house.

I, therefore, request you to kindly investigate into the matter and please take appropriate strong legal action against my husband and my In-laws, under the relevant sections of law after treating my written complaint as an FIR and obliged thereby.
