I Sakin Ali, S/O- Late Abdul Karim, resident of Jorepakri, P.O- Bhaktinagar, P.S- Bhaktinagar (now NJP), Dist- Jalpaiguri, would like to inform you kind information and necessary action-


1. That I am the owner of the piece and parcel of land measuring 1 acre 45 decimal appertaining Khatian no- 2748 (old 369) R.S . Plot no- 416,419,420,603,604, and 569, sheet no- 11, Mouza- Binnaguri, P.S- Bhaktinagar (now NJP), Dist Jalpaiguri, the said land was purchased by Sakin Ali vide Registered deed no- 1993 dated 11.04.1958.
2. That I had also filed a Civil suit against Sukla Paul vide no- 150 of 2012 in respect of land measuring 1 acre 45 decimal appertaining to Khatian No- 2748 (old 369) R.S . Plot no- 416,419,420,603,604, and 569, sheet no- 11, Mouza- Binnaguri, P.S- Bhaktinagar, Dist Jalpaiguri and a permanent injunction decree was passed on 18.03.2023 against Sukla Paul and Sukla Paul was directed not to disturb the peacefully possession of me in respect of said land.
3. That therefore Sukla Paul in order to defraud me, with malicious intentions in connivance with Nasirul Islam has sold out 17 decimal of land through a registered deed of sale being No- 4258 for the year 2023 on 8/06/2023 in favour o Nasirul Islam , Son of Masiruddin, resident of Purba Shantipara, P.O- Dabgram, P.S- New Jalapaiguri, Dist- Jalapaiguri, area measuring 17 decimal, within Mouza Binnaguri, R.S- Plot no- 419 corresponding to L.R Plot no- 600, recorded in L.R. khatian 2232 ,that Sukla Paul Wife of Late Akhil Chandra Paul, resident of suryasen Colony, Block- d, P.O & P.S- Bhaktinagar, Dist- Jalapaiguri, has already lost the suit filed by me before the civil Judge Junior Division at Jalapaiguri, being Title Suit No- 150/2012 vide order and decree dated 18/03/2023 and 27/03/2023 and the said deed of sale has been executed by Sukla Paul and her son Jony Paul.

4. That therefore knowing all fact Nasirul Islam has mutated his name in respect of 17 decimals of land recorded in L.R. Khatian no- 6428, within Mouza- Binnaguri, in respect of L.R. Plot no- 600, corresponding to R,S. Plot no- 419 illegally by way of manufactured document without any force of law suppressing all the aforesaid material fact and try to enter into the land by filling Title suit no- 45 of 2024 filed against one Humayun Kabir at first point of time but failed to do so due to the resistant, that Nasirul Islam alongwith his son M.R. Rahaman and others land mafia has defrauded me by way of cheating and created false Khatian without having any right title and interest therein by submitting illegal document in order to deprive me from my valuable property with common intention and illegally interfering with title and possession of my aforesaid property.
5. That lastly on 3.08.2025 the said Nasirul Islam, M.R.Rahaman and other have again forcefully tried to enter into the land and broke the boundary fencing and tried to capture my land illegally.
6. That Sukla Paul, Jony Paul and Nasirul islam, M.R. Rahaman along with Indrajit Debnath have tried to defraud,cheat and forgery upon me by manufacturing a void document illegally, in order to deprived me of my lawful right, title and interest over my land in which I have already got decree from the competent court of law.

Under the aforesaid circumstances I request before your good office to register a criminal case BNS Act against the above accused persons namely Sukla Paul, Jony Paul, Nasirul Islam and M.R. Rahaman further be pleased to take any other necessary steps in this regard and oblige.
