Sir,

I, Sri Manik Das, (45), Assistant Engineer (Electrical) & Station Manager, NJP Gate Bazar C.C.C, WBSEDCL, (S/O: Sri Akshay Das), do hereby lodge complaint against aforesaid Shri Subrata Kundu to the effect that, on 07.08.2025 in course of inspection, myself along with Shri Bhoben Roy, S/O: Late N.C Roy, SO of Darjeeling Regional office, WBSEDCL, Sukanta Talukder, Sr. Office Executive, S/O- Late Santosh Talukder, Shri Suren Turi, Sr. T.S.H, S/O: Late Lokenath Turi of NJP Gate Bazar CCC & other technical staff of NJP Gate Bazar CCC had been to the premises of Sunil Kumar Kundu of Surya Sen Colony, Block F, P.S- NJP, Dist: Jalpaiguri at 12.30 Hrs. Prior entry to the premises, a notice was issued in the name of Sunil Kumar Kundu for inspection of the said premises which was received by Shri Subrata Kundu, who was introduced himself as a son of Sunil Kumar Kundu and told us that he is the present user of the existing service connection as Sunil Kumar Kundu was died. I arrange to call witnesses from the vicinity but none turned up. However, in presence of the present user of the said premises I conducted inspection.

During inspection it was found that, there has one domestic connection vide consumer id: 412136380 in the name of Late Sunil Kumar Kundu in the premises, & his son Shri Subrata Kundu, the present user has made unauthorized extension of line to other the premises, where there has a disconnected service line vide consumer number 400043892 in the name of Sanjita Khatun having outstanding due amount Rs. 54,488.38 including assessed LPSC as on date. Due to this unauthorized use of electricity WBSEDCL has occur a loss of revenue. On detection of such illegal use of electricity service line in the name of Sunil Kumar Kundu was disconnected & meter was dismantled. During inspection load of electricity consumption as observed in the same premises was 0.56 KVA. On being asked, Shri Subrata Kundu admitted his guilt for committing aforesaid offence. Thus it has well been established that, aforesaid Shri Subrata Kundu, S/O: Late Sunil Kumar Kundu of Surya Sen Colony, Block F, P.S. NJP, Dist: Jalpaiguri has committed offence for which he is liable for prosecution U/S 135(1) (e) of The Electricity Act' 2003 amended in 2007.

Inspection report was prepared. I seized the following article under proper seizure list on 07.08.2025 from 13.00 hrs. to 13.15 hrs at the same premises in presence of the consumer.

Seizure: -

1. One Single phase meter, vide meter number L1684212, Landis Gyr make, 5-30 Amp, 230 Volt.

Copies of seizure list and inspection report were delivered to Shri Subrata Kundu.

Therefore, I request you to kindly treat this complaint as F.I.R. against aforesaid Shri Subrata Kundu and arrange for it's investigation.

Original inspection report, seizure list, notice, one sealed packet containing seized article affixed with original label and another seal packed C.D containing video recording are being handed over to you for necessary action.
