I, Smt Gopa Chowdhury, w/o Late. Prithwiraj Chowdhury, a resident of Pradhan Nagar Siliguri, aged 75 years. That I was the sole proprietor of M/S Sphulinga Gas Agency, situated at College para, Siliguri till June 2022.

Under various health & financial issues, i had to apply for partnership with Mr. Subhankar Paul, S/o Subir Paul, resident of Subhaspally Siliguri, which was accepted by Indian Oil Corporation in July 2022.

Thereafter, i being the 51% share holder (partner) of the said firm, is constantly denied entry to my office premises everytime i attempted to seek financial and accounce related information and also to look after the current affairs of the business.

Last time i had tried to enter my office on the 5th of August 2025 for the above-mentioned reasons, but was stopped by Mr. Subir Paul, Subhankar Paul, Sarbani Paul, Amal Sarkar (Staff) Babai Saha (Staff) forcefully and they had harassed me using filthy language at the top of their voice & also harassed me physically, mentally and abused me verbally. The same scenario happened in 2022 November where i had filed a GD at your Police station but that time they've hired some unknown faces who attacked me in the same way as i mentioned. That time i had mistakenly not mentioned the names stated above, as i was worried they would stop paying my monthly comission which is the only source of income. Also i came to know later that the entire incident of 2022 was planned by my partner & his family members.

It's a very critical and unhealthy situation, as they're trying to take over my entire business and denying me my rights completely as a 51% share holder (Partner).

I beg to you to look into the matter & take appropriate legal action as deemed fit by you Sir as I'm a 75 year old senior citizen and also being a lady I'm extremely helpless and insecured about myself & the business.
