With due respect, I am producing herewith the 05 (five) arrested accused persons namely (i) **Tamang (23)**, S/o- Shiba Tamang of Mokaibari, PS- Kurseong, Dist- Darjeeling, (ii) **Manmohan Barman** (22), S/o- Mantu Barman of Bidhanpally, Shibmandir, PS- Matigara, Dist- Darjeeling, (iii) **Bikash Ch. Roy** (32), S/o- Lt. Birendra Nath Roy of Himul Main Gate, PS- Matigara, Dist- Darjeeling, (iv) **Biswajit Biswas** (18), S/o- Lt. Ramprasad Biswas of South Colony, PS- NJP, Dist- Jalpaiguri and (v) **Pashunath Barman** (28), S/o- Naren Barman of Himul Main Gate, PS- Matigara, Dist- Darjeeling and the following articles under seizure :-

1. One iron made Shabol measuring approximately 1.5 feet from the possession of accused named Manmohan Barman.
2. One torch light from the possession of accused person named Bikash Ch. Roy.
3. One iron rod measuring approx 2.5 feet from the possession of accused person named Biswajit Biswas.
4. One screw driver and one plus from the possession of accused named Pashunath Barman.
5. One iron dye measuring approx 1.5 feet and one blue colour 220 Bajaj Pulsor motor cycle having Registration No. WB 74 U 1655 from the possession of Manish Tamang.

I, ASI Chandra Prakash Adhikari of Matigara PS, Siliguri Police Commissionerate beg to state that on 12.08.2025 at 00.40 hrs, received a secret source information that a gang of miscreants were assembled at abandoned shed at Paribahan Nagar parking area under Matigara PS, Dist.- Darjeeling with deadly weapons and making preparation for committing dacoity at Matigara area. Accordingly, I informed the fact to I/C, Matigara PS and as per his kind order myself along with ASI Pema Dorjee Sherpa, C/219 Sanatan Chitrakar, C/868 Sujal Roy, C/523 Sanjit Kundu all are of Matigara PS, Siliguri Police Commissionerate left for Paribahan Nagar parking, PS- Matigara, Dist.- Darjeeling to work out the information in hand vide Matigara PS GDE No. 595, Dated- 12.08.2025. At about 00.55 hrs on 12.08.2025 we arrived at an abandoned shed at Paribahan Nagar Parking under Matigara PS. After arrival of the spot and as identified by the source we found that 10/12 persons were assembled at under the shed and they were whispering in a very low voice. Accordingly we cordoned the place properly and approach towards them very slowly and carefully. But seeing the police party they started to flee away but we managed to apprehended 05 (five) persons of them. On interrogation, the apprehended accused persons disclosed their name and identity as noted above (not verified) and also disclosed that they assembled there for making preparation for committing dacoity in Matigara Bazar area. They also stated that others 05/07 associates were able to fled away from the spot by taking advantages of darkness. On being searched of the apprehended accused persons, found the above noted article from their possessions. Accordingly, I seized the above noted articles under proper seizure list and arrested the above noted 05 (five) accused persons under proper memo of arrest and observing all the formalities of arrest. The search seizure was made in between 01.02 hrs to 01.15 hrs on 12.08.2025. The whole process of search & seizure was made under video graph.
