In producing herewith one (01) arrested person namely Prakash Paswan (20 yrs) S/O Parichan Paswan of Debidanga, Kalkut, Opposite Debidanga Petrol Pump, Champasari, PS- Pradhan Nagar, Dist. Darjeeling under arrest along with the following articles under proper seizure viz:-(i) One (01) black colour backpack, with 03 compartment styled as "NIKE" containing forty (40) bottles of Codeine Phosphate & Triprolidine Hydrochloride syrup "REXLEY-T", each bottle containing 100 ml i.e. total (40 x 100 ml = 4000 ml) having batch no. MLS25319, Mfg date 05/25, Exp date 04/27, MRP Rs. 175.00 each, marked as Exhibit "A". I, SI Rajiv Subba, S/O Basant Subba of Pradhan Nagar PS, Siliguri Police Commissionerate do hereby lodged this written complaint against the above noted arrested accused person to the effect that on 05.08.2025 at 23.05 hrs I received a reliable specific secret source input that one person possessing huge quantity of illegal contrabands without any valid license would be come to Gurung Busty More under Pradhan Nagar PS, Dist- Darjeeling to deliver the same to his designed customers.

Accordingly, the matter was diarized in PS General Diary vide Pradhan Nagar PS GDE No. 836 dated 05.08.25 and I share the information with you in writing. Subsequently, as per your kind direction at about 23.15 hrs myself along with SI Goutam Mallik, ASI Prabal Sarkar, ASI Biplab Kumar Das, C/1413 Sujit Sarkar and C/1416 Dilip Barman all of Pradhan Nagar PS, SPC left for Gurung Busty More under PS- Pradhan Nagar, Dist. Darjeeling without any search warrant or authorization for search which could not be possible to obtain from a competent authority and for sudden development of a sensitive information and not to afford him opportunity for concealment of evidence or facility for his escape. This refers to Pradhan Nagar PS GDE No. 837 Dated 05.08.2025 and M.C.C. No. 1842/25 dated 05.08.25. I also informed one Videographer namely Somnath Chatterjee, S/O Sushil Chatterjee of Aurabinda Pally, Gokhel Road, Ward No 22, PS- Siliguri, Dist- Darjeeling over telephone and requested him to come to Gurung Busty More with his camera for the purpose of video graphs if required. I also requested RT van officer ASI Sajal Das to come to Gurung Busty More with his team to accompany us and share the information with him. On the way, I briefed all the Police personnel properly sharing the information in hand.

At about 23.25 hrs on arrival at Gurung Busty More, I requested two available independent persons namely (i) Arun Sahani (25 yrs), S/O Upendar Sahani of Reajendra Nagar, Coolipara, Ward No. 01, PS- Pradhan Nagar, Dist. Darjeeling and (ii) Raja Sahani (26 yrs), S/O Chunchun Sahani of Reajendra Nagar, Coolipara, Ward No. 01, PS- Pradhan Nagar, Dist. Darjeeling and shared the information with them and requested them to remain present and act as witness if any search and seizure would be made, which they agreed and gave concent verbaly. I also issued notice to the above mentioned two independent witnesses. In the meantime RT van officer ASI Sajal Das and along with his team arrived there and accompanied us as well as videographer namely Somnath Chatterjee also arrived at the spot. Accordingly, I issued a notice to him for a video graph the entire process of search and if required seizure. I briefed them properly. Then, I contacted my source who stated that the suspect carrying illegal contraband will come shortly to deliver the same to his designated customers. At around 23.55 hrs as identified by the source, we noticed that one person carrying one black colour back pack on his back was coming towards Gurung Busty More on foot from Siliguri Junction side. Accordingly, we cordoned the place from every possible corner and managed to detain him with one black colour back pack on his back at Gurung Busty More under Pradhan Nagar PS, Dist. Darjeeling. Thereafter, we disclosed our identities as Police personnel (as I along with 4/5 police personnel were in civil dress for our convenience) and informed him regarding the information in hand. On interrogation, the detained person disclosed his identity as Prakash Paswan (20 yrs) S/O Parichan Paswan of Debidanga, Kalkut, Opposite Debidanga Petrol Pump, Champasari, PS- Pradhan Nagar, Dist. Darjeeling and also disclosed that he possessed cough syrup in his bag and came there to deliver the same to his designated customer. Then, I issued notice in writing to him whether he wanted to search his bag in presence of an Executive Magistrate or any Gazetted Officer as per norms of u/s 50 of NDPS Act, upon which he agreed to be searched in presence of any of the above noted officers.

Accordingly, I informed the matter to you over mobile phone and requested you to arrange an executive Magistrate or Gazetted Officer to supervise the entire process of search and if required seizure. Furher at around 00.55 hrs on 06.08.25 you arrived at the spot at Gurung Busty More under PS- Pradhan Nagar, Dist- Darjeeling to perform the duty of gazetted officer being the I/C of Pradhan Nagar PS and informed me that due to odd hours of night no Executive Magistrate was available and as a gazetted officer you are legally authorised to give order to search bag of the suspect.

Then, I served a notice to you to supervise the entire process of search and if required of seizure. Then on camera, I offered both the independent witnesses and the detained person to search our Police Personnel as per provisions of law but they denied searching the Police personnel. Thereafter, in presence of you and independent witnesses noted above, I searched the black colour back pack of the above mentioned detained person namely Prakash Paswan (20 yrs) S/O Parichan Paswan of Debidanga, Kalkut, Opposite Debidanga Petrol Pump, Champasari, PS- Pradhan Nagar, Dist. Darjeeling and recovered forty (40) bottles of Codeine Phosphate & Triprolidine Hydrochloride syrup "REXLEY-T", each bottle containing 100 ml i.e. total (40 x 100 ml = 4000 ml) having batch no. MLS25319, Mfg date 05/25, Exp date 04/27, MRP Rs. 175.00, from the back pack of the said detained person. On demand in presence of you and independent witnesses, the above mentioned detained person namely Prakash Paswan (20 yrs) S/O Parichan Paswan of Debidanga, Kalkut, Opposite Debidanga Petrol Pump, Champasari, PS- Pradhan Nagar, Dist. Darjeeling failed to produce any valid document/paper for possessing or selling such huge quantities of Codeine Phosphate based Cough Syrup. On further grilling, he confessed his guilt and stated that he procured the said quantities of "Codeine Phosphate based Cough Syrup" clandestinely from one of his suppliers for the purpose of selling the same in high rates to his selected customers. He also stated that he was running such a business illegally for the last few months for his wrongful gain.

Accordingly, I seized the said articles viz: (i) One (01) black colour backpack, with 03 compartment styled as "NIKE" containing forty (40) bottles of Codeine Phosphate & Triprolidine Hydrochloride syrup "REXLEY-T", each bottle containing 100 ml i.e. total (40 x 100 ml = 4000 ml) having batch no. MLS25319, Mfg date 05/25, Exp date 04/27, MRP Rs. 175.00, Marked as Exhibit "A", from the possession of accused person namely Prakash Paswan (20 yrs) S/O Parichan Paswan of Debidanga, Kalkut, Opposite Debidanga Petrol Pump, Champasari, PS- Pradhan Nagar, Dist. Darjeeling under proper seizure list in presence of you and independent witnesses and obtained their signatures which are acknowledged by the accused person. Subsequently, I sealed and labelled the seized contraband articles in presence of you and independent witnesses and the above noted accused at the spot. The entire process of search, seizure and labelling were made under the coverage of a video graph executed by the videographer namely Somnath Chatterjee, S/O Sushil Chatterjee of Arabinda Pally, Gokhel Road, Ward No. 22, PS. Siliguri, Dist.- Darjeeling in between 01.10 hrs to 02.05 hrs on 06.08.25 as per norms of BNSS.

From the above noted facts and seizure of incriminating articles, it is quite evident that the offender namely Prakash Paswan (20 yrs) S/O Parichan Paswan of Debidanga, Kalkut, Opposite Debidanga Petrol Pump, Champasari, PS- Pradhan Nagar, Dist. Darjeeling is involved in procuring and selling "Codeine Phosphate based Cough Syrup" illegally contravening the provisions of NDPS Act. Then, I arrested him after observing all formalities of arrest, informing him regarding the ground of his arrest.

Under the above fact and circumstances, I pray before you that a specific case under proper sections of law may kindly be registered against the arrested person namely Prakash Paswan (20 yrs) S/O Parichan Paswan of Debidanga, Kalkut, Opposite Debidanga Petrol Pump, Champasari, PS-Pradhan Nagar, Dist. Darjeeling and kindly arranged its investigation.
