Sir,

In producing herewith four (04) accused persons namely (i) Bigen Mahato (M-24) S/o Rajendar Mahato of Lohar Patty, Gurung Busty, P.S. Pradhan Nagar, Dist. - Darjeeling (ii) Rohit Hela (M-21) S/o Rabi Hela of Dhaknikata near Radha Gobinda Mandir, P.O. Champasari, PS- Pradhan Nagar, Dist. Darjeeling (iii) Tun Tun Paswan (M-22) S/o Gajen Paswan of Natun Bazar, P.O. Champasari, PS- Pradhan Nagar, Dist. Darjeeling and (iv) Akash Sarkar (M-24) S/o Teju Sarkar of Dhaknikata near Shib Mandir, P.O. Champasari, P.S. Pradhan Nagar, Dist. Darjeeling under arrest along with the following seizure articles viz :- (i) One iron made breaking instruments locally called as "Sabol" measuring 17 inches in length (ii) one sharp cutting iron made weapon locally called as "Hasua" measuring 25 inches in length including its 7 inches wooden butt (iii) one iron made instruments called as Plus (iv) one iron made sharp cutting weapon locally called as "Degar" measuring approx 17 inches in length including its 6 inches wooden butt (v) one iron made "Hammer" measuring 12 inches in length and (vi) one multi colour nylon bag.

I ASI Biplab Kr. Das of Pradhan Nagar PS, SPC do hereby lodge this written complaint against the above noted four (04) arrested accused persons and others 06/07 unknown miscreants who involve in this crime to the effect that on 07.08.2025 at 00.20 hrs I received a specific source information that about 11/12 miscreants equipped deadly weapons assembled at Dhaknikata near Lal Building under PS- Pradhan Nagar, Dist. Darjeeling and they are making preparations for committing Dacoity at Dhaknikata and its surrounding area. Accordingly, I diarized the fact in P.S. General diary vides Pradhan Nagar PS GDE No. 420/25 dated 07.08.205 and informed the matter to you. As per your kind order and direction I accompanied SI Rajiv Subba, ASI Prabal Sarkar and force all of Pradhan Nagar PS, SPC left for Dhaknikata under PS- Pradhan Nagar, Dist.- Darjeeling by Govt. vehicle with investigation kits to verify the veracity of the information without any search warrant or authorization for search which could not be possible to obtain from a competent authority for sudden development of a sensitive information and not to afford them opportunity for concealment of evidence or facility for their escape. I informed R.T. van officer ASI Buddi Bal Subba and force of Pradhan Nagar PS and directed him to come to Dhaknikata near Lal Building near Prumary School under PS- Pradhan Nagar, Dist. Darjeeling to accompany us. At around 01.15 hrs we reached at Dhaknikata near Lal Building under PS- Pradhan Nagar, Dist. Darjeeling and after a while R.T. van officer ASI Buddi Bal Subba and force arrived there and accompanied us. I shared the information with them and briefed them properly. Then, I requested two available independent witnesses namely (i) Arun Sahani (25 yrs), S/O Upendar Sahani and Raja Sahani S/o Chun Chun Sahani and shared the information with them and requested them to remain present and act as witness if any search and seizure would be made, upon which they agreed. Then, I contacted my source and from a considerable distance he pointed the place where the miscreants were assembled.

Thereafter, we proceeded towards the place being identified by the source and cordoned the place from every corner with due care and caution and from a considerable distance we noticed that some persons were assembled at Dhaknikata near Lal Building under PS- Pradhan Nagar, Dist. Darjeeling and they were whispering in a low voice. On seeing police personnel approaching them they tried to flee away from the spot but on hot chase we managed to apprehended above noted four (04) accused persons while 06/07 others unknown miscreants managed to flee away through others exit points, taking the advantage of darkness.

Thereafter, we disclosed our identities as Police personnel (as we were in civil dress for our convenience). On interrogation, they disclosed their identities as noted above. On search recovered the above noted weapon of offence from their joint possession which they kept concealed inside a multi colour nylon carry bag.

On further interrogation, they furnished incoherent statements and failed to give any satisfactory reply for their presence with deadly weapons in such deaf hour of night. Finally they disclosed that they along with 06/07 of their associates assembled there and were making preparations for committing Dacoity at Dhaknita near Lal Building and its surrounding area. Accordingly, I seized the above mentioned weapons of offence from their joint possessions under proper seizure list in between 01:25 hrs to 02:25 hrs at the spot in presence of witnesses and duly signed by the witnesses and acknowledged by the accused persons and subsequently arrested them under proper memo of arrest and observing all the formalities of arrest. They are informed on the ground of their arrest. The whole process of search and seizure were made under the coverage of videography as per norms of BNSS and brought all the four (04) arrested accused persons along with seized articles to Pradhan Nagar Police Station for further investigation. From the above noted facts and seizure of incriminating articles there is strong reason to believe that all the above noted four (04) accused persons along with 06/07 of their associates who fled away gathered there equipped with deadly weapons at such deaf hour of night and taking preparation to commit Dacoity in a nearby affluent area at Dhaknikata and its surrounding area.

Under the above circumstances, I pray before you that a specific case under proper section of law may kindly be started against the above noted four (04) arrested accused persons (i) Bigen Mahato (M-24) S/o Rajendar Mahato of Lohar Patty, Gurung Busty, P.S. Pradhan Nagar, Dist. - Darjeeling (ii) Rohit Hela (M-21) S/o Rabi Hela of Dhaknikata near Radha Gobinda Mandir, P.O. Champasari, PS- Pradhan Nagar, Dist. Darjeeling (iii) Tun Tun Paswan (M-22) S/o Gajen Paswan of Natun Bazar, P.O. Champasari, PS- Pradhan Nagar, Dist. Darjeeling and (iv) Akash Sarkar (M-24) S/o Teju Sarkar of Dhaknikata near Shib Mandir, P.O. Champasari, P.S. Pradhan Nagar, Dist. Darjeeling and others 06/07 unknown miscreants who fled away from the spot and arranged for its investigation.


