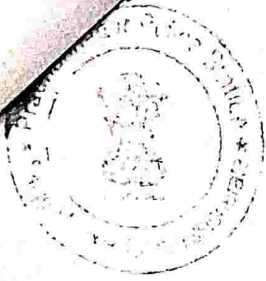

Respected Sir,

Myself Tultuli Orao, W/o. Diuse Kujur, D/o. Ratia Orao, R/o. Lede busty, Kalkut mauza, under Pradhan Nagar Police Station, P.O. Champasari, Dist. Darjeeling. I would like to inform you that we are tribal by caste and we had a piece of land of 6 bigha at Kalkut mauza which is the ancestral land of us and which has already grabbed by some local people. Now we also have a piece of land of measuring approx 16 katha bearing details of L.R. Plot no. 703 & 703/724 of Kalkut mauza, J.L no. 44, under P.S. Pradhannagar, Dist Darjeeling which is our ancestral property and now recorded in the name of my father RatiaOrao vide L.R. khatian no. 5469. Being an old age person aged about 65 years old and for his massive ailments and our illiteracy and poverty, my father became repeatedly failure to maintain his possession from some local people namely Dr. Khagendra Nath Roy, Uttam Roy, Amit Saha, Md. Sabir, Sisir Biswas, Gopal Das, Kalicharan Das, Jagadish Roy and Hunu Das (husband of local TMC panchayat member) are trying to disturb, grabbing and dispossession our peaceful possession from the above mentioned 16 katha land alongwith their men who are local hooligans also from a very long tenure. In this regard we have approached verious platform of administration but no gainful response we have received yet.

Today i.e. on 7/08/2025 morning I alongwith my husband and some labour and instruments reached to our above mentioned land and



tried to fencing over our own land but again the above mentioned accused attacked us and deprived us from entering into our land and creating public nuisance over there. I repeatedly contacted your good office regarding this matter and furnished all the valid relevant documents before your kind gesture, now I want to proceed against them legally. This is a clear indication of the immoral and malafide intention of the above mentioned accused for grabbing our ancestral tribal land.

That my request is to you and pray for your kind cooperation to do the needful for saving our tribal land from the land grabber intentionally.
