Sir,

In producing herewith three (03) accused persons namely (i) Karan Sha (20Yrs) S/O Ajay Sha of Ball Khela Math, Sraman Nagar, Champasari, Pradhannagar PS, Dist Darjeeling, (ii) Shajhat Alam (20yrs) S/O Lt. Md. Hakimuddin of Debidanga 4 no. Adha Ghat, Champasari, Pradhannagar PS, Dist Darjeeling, (iii) Anjay Sharma (24yrs) S/O Suranjan Sharma of Dharam Nagar, Cooliepara, Ward No. 01, PS Pradhannagar, Dist Darjeeling, under arrest along with the following seizure articles viz :- (i) One sharp cutting weapon locally called as "Hasua" measuring approx 22 inches in length including wooden handle (ii) One iron rod approx measuring 24 inches in length, (iii) One iron made "Hammar" including its wooden handle, (iv) One iron made sharp cutting weapon locally called as "Bhojali" approx measuring 16 inches in length including its wooden handle, (v) One iron made "Sabot" measuring approx 16 inches in length, (vi) One iron made "Plush", (vii) one blue colour nylon carry bag.

I SI Rajiv Subba of Pradhan Nagar PS, SPC do hereby lodge this written complaint against the above noted three (03) arrested accused persons and others 08/09 unknown miscreants who involve in this crime to the effect that on 08.08.2025 at 00.20 hrs I received a specific source information that about 11/12 miscreants equipped deadly weapons assembled in at abandoned house near Parbati Ghat, Bagajatin Colony, under PS- Pradhan Nagar, Dist. Darjeeling and they are making preparations for committing Dacoity at Bagajatin Colony and its surrounding area. Accordingly, I diarized the fact in P.S. General diary vide Pradhan Nagar PS GDE No. 479 dated 08.08.2025 and informed the matter to you. As per your kind order and direction I accompanied SI Bandhan Roy, ASI Biplab Kumar Das, ASI Prabal Sarkar and force all of Pradhan Nagar PS, SPC left for Parbati Ghat, Bagajatin Colony under PS- Pradhan Nagar, Dist.- Darjeeling by Govt. vehicle with investigation kits to verify the veracity of the information, vide Pradhannagar PS GDE No. 480 dated 08.08.2025, without any search warrant or authorization for search which could not be possible to obtain from a competent authority for sudden development of a sensitive information and not to afford them opportunity for concealment of evidence or facility for their escape. I informed night van officer SI Pranab Singh of Pradhan Nagar PS and requested him to come at Parbati Ghat, Bagajatin Colony, to accompany us. At around 00.45 hrs we reached Parbati Ghat, Bagajatin Colony, in the meantime R.T. van officer SI Pranab Singh and force also arrived there and accompanied us. I shared the information with them and briefed them properly. Then, I requested two available independent witnesses namely (i) Raja Sahani (26 yrs), S/O Chunchun Sahani of Reajendra Nagar, Cooliepara, ward no. 01, PS- Pradhan Nagar, Dist. Darjeeling and (ii) Somnath Chatterjee S/O Sushil Chatterjee of Santinagar Bou Bazar, PS Bhaktinagar, Dist Jalpaiguri, and shared the information with them and requested them to remain present and act as witness if any search and seizure would be made, upon which they agreed. Then, I contacted my source and from a considerable distance he pointed to the place where the miscreants were assembled.

Thereafter, we proceeded towards the place being identified by the source we cordoned the place from every corner with due care and caution and from a considerable distance. we noticed that some persons were assembled at an abandoned house, situated at near Parbati Ghat, Bagajatin Colony, under PS- Pradhan Nagar, Dist. Darjeeling and they were whispering in a low voice. On seeing police personnel approaching them they tried to flee away from the spot but on hot chase we managed to apprehended above noted three (03) accused persons while 08/09 others unknown miscreants managed to flee away through others exit points, taking the advantage of darkness.
