Sub: F.I.R for the Theft, Wrongful & physical assault, Threat with dire consequence, Wrongful assault on 10 years minor child, Attempt to murder and Criminal intimidation.

Respected Sir, I Subnum Parveen w/o Sk.Samjad Ali presently residing at thiknikata, near NBMC&H gate no.1, sushrutanagar, Siliguri-734012. I would like to state that on 07.08.2025 at around 7 pm I was going to my friend place in pradhan nagar with my son, suddenly I saw near Hotel Sundaram palace one red swift car bearing no.**WB74BL4924** which was driven by 1)**Md.Khalilullah sheikh** s/o Habibullah sheikh mob.6295994866 and 2)**Habibullah sheikh** s/o late.Sk. Sikander ali mob. 9434070251,was sitting in front seat and 3)**Shahnaz khaton** w/o Habibullath sheikh mob. 9002008021 resident of c/o Akber ali Kamrangaguri near sattelite tower,Siliguri-734015 and 4)**Shama parveen** w/o Subhanullah khan was sitting at back seat, they are well known to me, coming towards me in excessively high speed in menacing manner with the Intention to kill me and my only minor child. Somehow i saved my child by pushing him aside but unfortunately the car hit me very badly and flung me against the wall with full force and I fall on the road unconsciously with torn clothes and I sustain physical injuries and bleeding continuosly. They all came out of the car and brutally assaulted me physically with iron rod left side on my head and beaten me and my minor child with cruelty, abused us and threatened us in filthy language that they will kill us if I will not take back case which is against them and even they snatched my gold chain from my neck which was worth Rs.1,80,000/- (one lakh eighty thousand only). As road was almost empty so they managed to escape when my Son started screaming. Later on my son called my relative and they took me to the medical for treatment.

Sir, they have tried to kill us many times because I stay alone with my only child and I have nobody to take care of and this time my head injury is very severe and I was in uncontrollable pain for two days and my son is in great shock and in mental trauma that he doesn't want to go out of the house for treatment, these people are very dangerous for the society and they can cross any limits for the sake of money, power & property, and they have no fear of law and order. They even uttered repeatedly that they keep police in their pocket.

Please lodge my First Information Report against these miscreants, and do the needful.
