Sir,

In producing herewith four (04) accused persons namely (i) Bikki Sahani (25), S/O Late Anandi Sahani of Rajendra Nagar, Coolepara, PS. Pradhan Nagar, Dist. Darjeeling, (ii) Bijay Oraon (#19), S/O Late Pora Raju Oraon, of Kolabari, Devidanga, PS. Pradhan Nagar, Dist. Darjeeling, (iii) Sourav Dorjee, S/O Shiva Dorjee of Dumsipara, PO. Ramjhora, PS. Madarihat, Dist. Alipurduar and (iv) Rabi Sarkar (19), Late Depu Sarkar of Dasharath Pally, W/No. 44, PS. Bhaktinagar, Dist. Jalpaiguri under arrest along with the following seizure articles viz :- (i) One iron made sharp cutting weapon locally called as "TOROWAL" measuring approx 33 inches in length, (ii) One iron made weapon locally called as "HASUA" measuring approx 28 inches in length including its wooden butt, (iii) One iron made weapon locally called as "DAGER" measuring approx 18 inches in length including its wooden butt, (iv) One iron rod locally called as "SABOL" measuring approx 24 inches in length, (v) One iron made hammer with its iron handle measuring approx 14 inches in length, (vi) One iron made instrument called as "PLUS" measuring approx 9 inches in length, (vii) One iron made axe and (viii) One multicolour nylon bag.

I SI Bandhan Roy of Pradhan Nagar PS, SPC do hereby lodge this written complaint against the above noted four (04) arrested accused persons and others 07/08 unknown miscreants who involve in this crime to the effect that on 11.08.2025 at 23.55 hrs I received a specific source information that about 11/12 miscreants equipped deadly weapons assembled in at abandoned railway quarter at B.R.I. Colony, under PS- Pradhan Nagar, Dist. Darjeeling and they are making preparations for committing Dacoity at Gate Bazar and its surrounding area. Accordingly, I diarized the fact in P.S. General diary vide Pradhan Nagar PS GDE No. 718 dated 11.08.2025 and informed the matter to you. As per your kind order and direction I accompanied SI Goutam Mallik, ASI Prabal Sarkar, ASI Bikash Roy and force all of Pradhan Nagar PS, SPC left for B.R.I. Colony under PS- Pradhan Nagar, Dist.- Darjeeling by Govt. vehicle with investigation kits to verify the veracity of the information without any search warrant or authorization for search which could not be possible to obtain from a competent authority for sudden development of a sensitive information and not to afford them opportunity for concealment of evidence or facility for their escape. I informed night van officer ASI Sanjay Sarkar of Pradhan Nagar PS and requested him to come at B.R.I. Colony, to accompany us. On arrival at B.R.I. Colony, in the meantime R.T. van officer ASI Sanjay Sarkar and force also arrived there and accompanied us. I shared the information with them and briefed them properly. Then, I requested two available independent witnesses namely (i) Arun Sahani (25 yrs), S/O Upendar Sahani of Rajendra Nagar, Cooliepara, ward no. 01, PS- Pradhan Nagar, Dist. Darjeeling and (ii) Raja Sahani (26 yrs), S/O Chunchun Sahani of Rajendra Nagar, Cooliepara, ward no. 01, PS- Pradhan Nagar, Dist. Darjeeling, and shared the information with them and requested them to remain present and act as witness if any search and seizure would be made, upon which they agreed. Then, I contacted my source and from a considerable distance he pointed to the place where the miscreants were assembled.

Thereafter, we proceeded towards the place being identified by the source we cordoned the place from every corner with due care and caution and from a considerable distance. We noticed that some persons were assembled at an abandoned railway quater, situated at B.R.I. Colony, under PS- Pradhan Nagar, Dist. Darjeeling and they were whispering in a low voice. On seeing police personnel approaching them they tried to flee away from the spot but on hot chase we managed to apprehended above noted four (04) accused persons while 07/08 others unknown miscreants managed to flee away through others exit points, taking the advantage of darkness.

Thereafter, we disclosed our identities as Police personnel (as we were in civil dress for our convenience). On interrogation, they disclosed their identities as noted above. On search recovered the above noted weapon of offence from their joint possession which they kept concealed inside one multicolor nylon carry bag.


On further interrogation, they furnished incoherent statements and failed to give any satisfactory reply for their presence with deadly weapons in such deaf hour of night. Finally they disclosed that they along with 07/08 of their associates assembled there and were making preparations for committing Dacoity at Gate bazar and its surrounding area. Accordingly, I seized the above mentioned weapons of offence from their joint possessions under proper seizure list in between 00.45 hrs to 01:10 hrs at the spot in presence of witnesses and duly signed by the witnesses and acknowledged by the accused persons and subsequently arrested them under proper memo of arrest and observing all the formalities of arrest. They are informed on the ground of their arrest. The whole process of search and seizure were made under the coverage of videography as per norms of BNSS and brought all the four (04) arrested accused persons along with seized articles to Pradhan Nagar Police Station for further investigation. From the above noted facts and seizure of incriminating articles there is strong reason to believe that all the above noted four (04) accused persons along with 07/08 of their associates who fled away, gathered there equipped deadly weapons at such deaf hour of night and taking preparation to commit Dacoity in a nearby affluent area at Gate Bazar.

Under the above circumstances, I pray before you that a specific case under proper section of law may kindly be started against the above noted four (04) arrested accused persons namely (i) Bikki Sahani (25), S/O Late Anandi Sahani of Rajendra Nagar, Coolepara, PS. Pradhan Nagar, Dist. Darjeeling, (ii) Bijay Oraon (119), S/O Late Pora Raju Oraon, of Kolabari, Devidanga, PS. Pradhan Nagar, Dist. Darjeeling, (iii) Sourav Dorjee, S/O Shiva Dorjee of Dumsipara, PO. Ramjhora, PS. Madarihat, Dist. Alipurduar and (iv) Rabi Sarkar (19), Late Depu Sarkar of Dasharath Pally, W/No. 44, PS. Bhaktinagar, Dist. Jalpaiguri, and others 07/08 unknown miscreants who fled away from the spot and arranged for its investigation.
