Sir

I'm producing herewith 01 (one) accused person namely Md Firoj @ Raj (27 years) S/O Md Ainul of 8 th Mile, near Petrol Pump, PS+Dist. Kalimpong under arrest and the following articles under seizure viz (i) 01 iron made improvised small fire arms measuring approx 25 cm in length including its 09 cm iron made pistol grip, having approx 15 cm barrel, trigger, firing pin and firing hammer in proper working condition - Marked as Exhibit 'A' and (ii) 01 (one) live ammunition- Marked as Exhibit - 'B').

I, SI Goutam Mallik of Pradhan Nagar PS, SPC do hereby lodged this written complaint against the above mentioned arrested accused person namely Md Firoj @ Raj (27 years) S/O Md Ainul of 8 th Mile, near Petrol Pump, PS+Dist. Kalimpong to the effect that today i.e. on 12.08.25 at 01.35 hrs I received a specific secret source information that one person is moving at Gurung Busty More area with illegal fire arms with a view to sell the same to his designed customer or to commit any heinous crime. Accordingly, I diarized the information in PS General diary vide Pradhan Nagar PS GDE No. 722 dated 12.08.25 and informed the fact to you. As per your kind order and direction myself along with ASI Biplab Kr Das, ASI Prabal Sarkar and force left for Gurung Busty More under P.S- Pradhan Nagar, Dist. Darjeeling with investigation kit to work out the information by Govt. vehicle vide Pradhan Nagar GDE No 722 dated 12.08.25 and MCC No 1891/25 dated 12.08.25. Under this circumstance any search warrant or authorization for search cannot be obtained for want of time. So we had to move fast without affording the miscreant, the opportunity for the concealment of evidence or facility for his escape. On the way to Gurung Busty, I directed night RT Van Officer ASI Sanjay Roy to come to Gurung Busty More to accompany with us. After arrival at Gurung Busty More, I contact with two independent persons namely (i) Raja Sahani (26 yrs), S/O Chunchun Sahani of Reajendra Nagar, Coolipara, Ward No. 01, PS- Pradhan Nagar, Dist. Darjeeling and (ii) Somnath Chatterjee (41 yrs) S/O Sushil Chatterjee of Santi Nagar, Bou Bazar, PS- Bhakti Nagar, Dist. Jalpaiguri and requested them to remain present and act as witness during search and seizure if required upon which they agreed. Then, I contacted with my source and as indicated by the source we noticed that one person was standing near Gurung Busty More under PS- Pradhan Nagar, Dist. Darjeeling. We cordoned the place from every corner with due care and caution. On seeing police personnel approaching towards him, he tried to flee away from the spot but on hot chase we could be able to apprehend him near Gurung Busty More. Thereafter, we disclosed our identities as Police personnel (as we were in civil dress for our convenience). On interrogation, he disclosed his identity as noted above. As per source information that he is possessing fire arms and ammunition hence immediately, I searched him and recovered the following articles viz - (i) 01 iron made improvised small fire arms measuring approx 25 cm in length including its 09 cm iron made pistol grip, having approx 15 cm barrel, trigger, firing pin and firing hammer in proper working condition - and (ii) 01 (one) live ammunition. On demand he failed to produce any document in respect of fire Arm and ammunition which was found in his exclusive and conscious possession. Accordingly, I seized the above mentioned articles from his possession in presence of independent witnesses noted above under proper seizure list and duly signed by the witness and acknowledge by the accused person. The search seizure and label were made in between 02.15 hrs to 02.50 hrs at the spot under the coverage of videography as per norms of BNSS. On further interrogation he admitted that he came there to delever the same to his design customer for his wrongful gain.

Thus, when his involvement in carrying and possessing illegal Fire arm and ammunition was established, I then arrested him under proper memo of arrest and observing all the formalities for violating the norms of Arms Act. I informed him regarding grounds of arrest and also issued copy of memo of arrest and ground of arrest to him.

Under the above noted facts and seizure of incriminating articles, there is strong reason to believe that the said accused person namely Md Firoj @ Raj (27 years) S/O Md Ainul of 8 th Mile, near Petrol Pump, PS+Dist. Kalimpong is desperate and dangerous in nature, as he was carrying the said Fire arm and live ammunition with an objective to sell the same or to commit any heinous crime in the locality.

As he wilfully violated the regulation of Arms Act, I, therefore pray before your good self that a specific case may kindly be initiated against the accused person namely Md Firoj @ Raj (27 years) S/O Md Ainul of 8 th Mile, near Petrol Pump, PS+Dist. Kalimpong under proper section of law and may arrange to cause its investigation.
