With utmost respect, I ASI (AB) 60 Basanta Barman hereby write to lodge a written complaint against Prajnadeepta Roy who identified himself as APP, Calcutta High Court, Debojyoti Goswami and his other associates. The fact of the incident in brief is that, I ASI (AB) 60 Basanta Barman along with CV/ 654 Rabi Roy CV/338 Ananta Roy and CV/656 Bhabananda Roy were performing Traffic regulation duty at Payel More, Sevoke Road under Bhaktinagar Traffic Guard. In the due course of time at around 18:30 hours on 10/08/2025, there was an altercation between two vehicle owners of vehicles bearing Reg. No. WB 38 AK 9781 and WB 74 BK 6463 and when I intercepted to stop the altercation and instructed to clear the road, the above noted individuals turned furious and started scuffling with me and my force and obstructed me from performing Govt. duty.

Additionally, the said person Prajnadeepta Roy, Debojyoti Goswami and other associates physically assaulted me and my force by fists and blows near the traffic booth and also dragged CV/ 624 Rabi Roy inside the traffic booth, physically assaulted him and tore apart his uniform and started vandalizing the booth causing damage to the Govt. property.

Subsequently, they placed the barricades forcefully in the middle of the road at Payel More, Sevoke Road causing huge traffic congestion on both sides at that peak hour of time continuously from 18:35 hours to 23:15 hours which stretched up to around 2 kilometers where in the general transport/private vehicles and most importantly emergency service vehicles such as ambulance were also stuck for a very long period of time.

Considering the above mentioned fact, I request you to kindly to start a specific case against Prajnadeepta Roy who identified himself as APP, Calcutta High Court, Debojyoti Goswami and his other associates under proper section of law for obstructing a Govt. official from performing Govt. duty, damaging Govt. property and causing unlawful gathering and disrupting public peace.
