I, **Shankhadeep Champati**, S/o Ardhende Sekhar Champati, resident of B-52, Shanti Nagar Housing Complex, Dabgram-2, Near FCI Godown, Siliguri, Pin - 734004, am working as a **Commercial Manager** at Reliance Digital, Sevoke Road, Siliguri.

I would like to bring to your attention that on **09/08/2025**, at around **9:39 PM**, an unidentified suspicious customer stole an **Apple MacBook Air** from the display fixture at our store. The incident came to our notice at approximately **10:00 PM**, after which I immediately informed our Store Manager, **Mrs. Manali Gupta**, and Security Manager, **Mr. Rana Paul**.

Upon reviewing the CCTV footage, it was observed that the unidentified person discreetly removed the laptop from the display and concealed it under his body before leaving the store premises.
