In producing herewith arrested accused person namely Sajia Bibi (F/26 yrs) W/O Md Kalam of Matangini-II, Tikiapara, Ward No. 28, PS- Siliguri, Dist- Darjeeling along with seized articles vize i) 20 (twety) sealed Plastik Bottles of Himalayan Gold 60 up country spirit each containing 600 ml. each, Amounting of Rs 160/- x 20 =RS. 3200/-) marked as Exhibits-A, ii) 01 (one) sealed Plastik Bottle of Himalayan Gold 60 up country spirit each containing 600 ml, Amounting of Rs 160/- in which was taken out from mother packet box as sample for examination, marked as Exhibits-A1, as per seizure list.

I, ASI Debasish Das of Siliguri PS, SPC do here by lodged a written complaint against above noted arrested accused person namely Sajia Bibi (F/26 yrs) W/O Md Kalam of Matangini-II, Tikiapara, Ward No. 28, PS- Siliguri, Dist- Darjeeling to the effect that on 12.08.25 at 14.25 hrs acting on secret source information that the above noted person was busy to sale Id liquor illegally in her house situated at Matangini-II, Tikiapara, Ward No. 28, PS- Siliguri in order to clandestinely dispose the same. Accordingly the fact is diarized in GD vide Siliguri PS GDE no. 563 dated 12.08.25 and informed the fact to I/C Siliguri PS. As per direction of I/C Siliguri PS, I along with ASI Rabin lama, LASI Kalpana Chhetri, LC-1295 Swastika Rai, C/160 Soumen Sarkar both of Siliguri PS left for Matangini-II, Tikiapara, Ward No. 28, PS- Siliguri to verify the veracity of the information vide Siliguri PS G.D.E No.564 dated 12.08.25. On reaching at 14.45 hrs there and as identified by source cordoned the above noted area where she was selling illegal alcohol. On seeing the police party the above noted person tried to escape from the spot but we managed to apprehend the above noted person with the help of lady force and on interrogation, she disclosed her identity as noted above. On being asked she stated that she used to sale the 60 up Country Spirit to her desigh costomer at her locality without any valid documents. On being asked she could not produce any valid documents in respect of the said liquor. On searching i) 20 (twety ) sealed Plastik Bottles of Himalayan Gold 60 up country spirit each containing 600 ml. each, Amounting of Rs 160/- x 20 =RS. 3200/-) marked as Exhibits-

A , II) 01 (one) sealed Plastik Bottle of Himalayan Gold 60 up country spirit each containing 600 ml, Amounting of Rs 160/- in which was taken out from mother packet box as sample for examination, marked as Exhibits-A1, and accordingly I seized the same as per seizure list as she has violated the norms of Bengal Excise Act for selling the said seized articles without any valid license. She also stated that she is doing this liquor business since long for her wrongful gain. Accordingly I seized the same in presence of witness duly signed by them. The seizure and label was made in between 14.55 hrs and 15.25 hrs. As such I arrested him U/S-35(1) BNSS after observing all sorts of rules after mainlining her decency.

Therefore I pray before your honor that a specific case may kindly be started against the arrested accused person namely Sajia Bibi (F/26 yrs) W/O Md Kalam of Matangini-II, Tikiapara, Ward No. 28, PS- Siliguri, Dist- Darjeeling along with seized 'articles under proper section of law and arrange for its investigate.
