I, Rajesh Agarwal, S/o M.K. Agarwal, Advocate by Profession, having my office at R.K. Agarwal & Associates, S.P. Mukherjee Road, Khalpara Siliguri-734005, hereby lodge the following complaint:

 That yesterday at around 4.45-5 p.m. one person namely Sri Manoj Upadhyay S/o Dwarika Upadhyay husband of my Junior Advocate Rima Upadhya tried to forcefully enter into my office premises without permission.

That my office staff have on earlier occasion asked him not to come to our office and create ruckus as the dispute between him and his wife is completely a matrimonial dispute and it ought to be discussed outside my office and that the matter is extremely personal and does not require my interference. The same should be settled at home or in the Court of law.

He also stated that he will set fire to my entire office and turn the same to ashes and he will create hurdle in my life and will cause lose to me on daily basis.
