Respected Sir/Madam,

I, Rajesh Agarwal, S/o M.K. Agarwal, Advocate by Profession, having my office at R.K. Agarwal & Associates, S.P. Mukherjee Road, Khalpara Siliguri-734005, hereby lodge the following complaint:


1. That yesterday at around 4.45-5 p.m. one person namely Sri Manoj Upadhyay S/o Dwarika Upadhyay husband of my Junior Advocate Rima Upadhyay tried to forcefully enter into my office premises without permission.
2. That my office staff have on earlier occasion asked him not to come to our office and create ruckus as the dispute between him and his wife is completely a matrimonial dispute and it ought to be discussed outside my office and that the matter is extremely personal and does not require my interference. The same should be settled at home or in the Court of law.

That he always use to throw two wheeler vehicles parked by my client on the road side and put scratch on four wheeler parked.

Yesterday at about he was in an intoxicated state, visibly under the influence of alcohol, and began abusing me and my office staff in filthy language and made various obscene gestures and acts that insulted the female members of my office.

5. When we asked him to leave our office, he however started threatening me with dire consequences, including threat to my life, saying words to the effect that he will break my skull with a iron rod and kill me. He further went to an extreme to threaten and intimidated other female members present in my office, using obscene and insulting language aimed at their modesty. He also stated that he will set fire to my entire office and turn the same to ashes and he will create hurdle in my life and will cause lose to me on daily basis.


