In producing herewith four (04) arrested accused persons namely (i) Sourav Saha @ Deep (19 yrs) s/o- Maheshwar Saha of Niranjannagar Chika More, ward no. 36, PO-Goghomali, PS- Bhaktinagar, dist- Jalpaiguri (ii) Subash Sikdar @ Ajay (30) s/o Lt. Surya Sikdar of Binoy More, Dakshin Shantinagar, PS- Bhaktinagar, dist- Jalpaiguri [not verified] (iii) Rohit Roy (26) s/o Lt. Hiralal Roy of Purba Majhabari, PO- Goghomali, PS-Bhaktinagar, dist- Jalpaiguri and (iv) Manik Haldar (29) s/o Amar Haldar of Majhabari near Jermel's School, PO- Goghomali, PS- Bhaktinagar, dist- Jalpaiguri arrested u/s- 35 BNSS along with following seized articles viz:

(1) One iron made rod measuring four feet (approx.) found from the possession of Manik

Halder which was kept in his left hand.

(2) One iron made hasua with plastic butt measuring 2.5inch (approx.) found from the possession of Sourav Saha which was kept in his right hand.

(3) One steel made knife with plastic butt measuring six inch (approx.) found from the

possession of Rohit Roy which was kept in his left hand.

(4) One iron rod measuring 12 inch (approx.) found from the possession of Subash Sikdar which was kept concealed in his back.

I, SI Agen Lepcha, S/O- Lt. Dup Tshering Lepcha of Ashighar OP under Bhaktinagar Police Station, Siliguri Police Commissionerate do hereby lodge this complaint against the abovenoted accused persons namely (i) Sourav Saha @ Deep (ii) Subash Sikdar @ Ajay (iii) Rohit Roy (iv) Manik Haldar and others to the effect that today on 12/08/2025 at 00:45 hrs while performing night patrolling duty received source information that 12/14 youths have assembled near Naresh More under Bhaktinagar PS with a view to commit dacoity in a house at Tellipara area. Accordingly, the fact was diarized in GD vide Ashighar OP GDE No-357 dated 12/08/2025. Subsequently, after sharing the information with my superior and as per his direction, I along with ASI- Tapan Roy, C/970 Bikash Roy, C/1547 Prabir Das, HG/ 114 Rabi Das, HG 1117 Subrata Das, HG/1149 Arun Roy all of Ashighar Out Post left for the Naresh More to verify the veracity of source information. At about 01:05 hrs after reaching near Naresh More under PS- Bhaktinagar, I met my source and being pointed by the source we started walking towards Naresh More. At around 01:10 hours, we reached at Naresh More and began to cordon off the suspected individuals identified by my source. We had a strong reason to believe that they were preparing to commit a cognizable offence and were about to leave the area. However, upon noticing the police approaching, they attempted to flee. After a hot chase, we successfully apprehended four accused individuals along with the seized articles mentioned above. Unfortunately, a number of others managed to escape from the spot taking advantage of darkness.

During interrogation, the apprehended individuals admitted that they had gathered there with the intent to commit dacoity at a house in the Tellipara area under the Bhaktinagar police station.

I thereafter, seized the above-noted weapons under the proper seizure list and videography duly signed by the witnesses and acknowledged by the accused persons. The whole seizure was made in between 01:18 hrs to 01:29 hrs. Following that, I arrested the above-noted accused persons u/s 35 BNSS under a proper memo of arrests duly signed by the accused persons and also supplied a copy of the memo of arrest to them.

Subsequently, I brought the arrested accused persons along with seized articles to Bhaktinagar Police Station for further investigation. During the course of interrogation, it could be revealed from the arrested accused persons that they were gathered there to commit

dacoity in a house in Tellipara area.

Hence, under the above noted facts and circumstances a specific case may kindly be started under proper section of Law against the above noted arrested accused persons viz (i) Sourav Saha @ Deep (19 yrs) s/o- Maheshwar Saha of Niranjannagar Chika More, ward no. 36, PO- Goghomali, PS- Bhaktinagar, dist- Jalpaiguri (ii) Subash Sikdar @ Ajay (30) s/o Lt. Surya Sikdar of Binoy More, Dakshin Shantinagar, PS- Bhaktinagar, dist- Jalpaiguri [not verified] (iii) Rohit Roy (26) s/o Lt. Hiralal Roy of Purba Majhabari, PO- Goghomali, PS-Bhaktinagar, dist- Jalpaiguri and (iv) Manik Haldar (29) s/o Amar Haldar of Majhabari near Jermel's School, PO- Goghomali, PS- Bhaktinagar, dist- Jalpaiguri] and others and arrange for its investigation.
