- 3. 02 (Two) bottles of BUDWEISER Magnum Lager beer each bottle containing 650 ML which MRP Rs-200/ per bottle. Total-1.3 liters. and marked as Exhibit-C one bottle taken as sample marked as Exhibit-C1
- 4. One multi colour big sac, SONA written in outside of the bag. (SL 1 to 3 was kept in SL no-4)

I beg to report that I, ASI Dipak Karmakar s/o Dulal Karmakar of Bhaktinagar PS under Siliguri Police Commissionerate lodged a written complainant against one the above noted person to the effect that on 12.08.25 at 16.05 hrs received a source information from Bangla bazar under Bhaktinagar PS that one person was standing with huge quantity of liquor in his possession for selling the same in the open market for his wrongful gain without any documents/license. Inform him about Ground of arrest in written. Seizure process was duly audio & Video graped. (The seizure was made in between 18.45 hrs to 19.25hrs)

I therefore request you a specific case may kindly be started against the accused person namely Suresh Rana-60yrs s/o Lt Jagbir Rana of Gowala busty, near saw mill, ward n0-43, PS Bhaktinagar Dist Jalpaiguri under proper section of law and arrange for investigation..
