Sir

In producing herewith following six arrested accused persons namely (1) Pranay Sherpa-30yrs s/o Palden Sherpa of Zila Parishad road, Ward No-41 PS Bhaktinagar, Dist Jalpaiguri (2) Avijeet @ Bang-20yrs s/o Aleswar Roy of Jyotinagar ward no-41 PS Bhaktinagar Dist Jalpaiguri (3) Rohit Sherpa @ Nanu-25yrs s/o Lt Kiran Sherpa of Sastrinagar Amtala PS Bhaktinagar Dist Jalpaiguri (4) Susanta Das-24yrs s/o Suraj Das of Vivekanandanagar, near Babu singh sporting club, ward no-42 PS Bhaktinagar Dist Jalpaiguri (5) Jyotish Haldar (28 yrs) S/O Lt Haradhan Haldar of Bottle company, Amtolla Shrastrinagar ward no 41, PS Bhaktinagar Dist Jalpaiguri (6) Sanju Das-19yrs s/o Dhiren das of Baikunthapally, near Kutru more, ward no-41 PS Bhaktinagar Dist Jalpaiguri along with following seized articles viz:

- 1) One iron made knife with wooden butt measuring approx 8 ½ inches recovered from the exclusive and Conscious possession of Pranay Sherpa.
- 2) One iron rod measuring approx 05 feet recovered from the exclusive and Conscious possession of Sanju Das.
- 3) One iron wrench measuring approx 06 inch recovered from the exclusive and Conscious possession Avijeet Roy @ Bang.

I, SI Srimanta Chatterjee s/o Lt Debi Prasad Chatterjee of Bhaktinagar PS, Siliguri Police Commissionerate do hereby lodge this complaint against the above noted persons and 3/4 others to the effect that on 13.08.25 at 00:10 hrs received a specific source information that 9/10 miscreants have assembled at an abundant SMC building, near Don Bosco more under Bhaktinagar PS, with deadly weapons and making preparation for committing dacoity to the passerby area. Accordingly I informed the matter to the I/C, Bhaktinagar PS and diarized the fact in General diary vide Bhaktinagar PS GDE No. 605 dated 13.08.25 and as per order I along with SI Youel Lepcha, ASI Mukul Bose with force (K-37 PS Mobile ), ASI Dipak Karmakar, ASI Mukul Bosu (CS-III mobile officer), and C/374 Debraj Biswas all of Bhaktinagar PS, SPC, left for an abundant SMC building, near Don Bosco more under Bhaktinagar PS to work out the information in hand vide GDE No-606 dated 13.08.25 & MCC No-4027/25 dated 13.08.25.

At about 00.25 hrs we arrived at the at an abundant SMC building, near Don Bosco more as indicated by the source we noticed that 9/10 persons assembled there and they were whispering in a very low voice. Accordingly, we cordoned the place properly and very carefully and approach towards them very slowly and carefully but seeing the police party they started shouting police and started to flee away from the spot but we the police party after somehow managed to apprehended above noted 06 (six) of them with deadly weapons in their possession but 3/4 persons managed to fled away from the spot taking the advantage of darkness and open place. On being asked the apprehended accused persons

disclosed their name and identity as noted above. During interrogation they stated that they were present there and making preparation for committing dacoity to the passerby area. On search the above noted weapon of offence recovered from their exclusive and conscious possession.

On further interrogation they give different statement in different time and failed to give any satisfactory reply for their presence with deadly weapons in the middle of the night.

Accordingly, I seized the above noted weapon of offence from their exclusive and conscious possession under proper seizure list in presence of witnesses duly acknowledged by the accused persons and subsequently, arrested them under proper memo of arrest also informed them about ground of arrest in writing and observing all the formalities of arrest the whole search seizure was made on 13.08.2025 in between 00.55hrs to 01.20hrs the whole seizure was conducted under proper audio video record.

Under the above noted fact and circumstance, I, therefore pray to you that a specific case under proper section of law may kindly be started against the arrested persons viz. (1) Pranay Sherpa-30yrs s/o Palden Sherpa of Zila Parishad road, Ward No-41 PS Bhaktinagar Dist Jalpaiguri (2) Avijeet Roy @ Bang-20yrs s/o Aleswar Roy of Jyotinagar ward no-41 PS Bhaktinagar Dist Jalpaiguri (3) Rohit Sherpa @ Nanu-25yrs s/o Lt Kiran Sherpa of Sastrinagar Amtala PS Bhaktinagar Dist Jalpaiguri (4) Susanta Das-24yrs s/o Suraj Das of Vivekanandanagar, near Babu singh sporting club, ward no-42 PS Bhaktinagar Dist Jalpaiguri (5) Jyotish Haldar (28years) S/O Lt Haradhan Haldar of Bottle company, Amtolla Shrastrinagar ward no 41, PS Bhaktinagar Dist Jalpaiguri (6) Sanju Das-19yrs s/o Dhiren das of Baikunthapally, near Kutru more, ward no-41 PS Bhaktinagar Dist Jalpaiguri and 3/4 others also arrange for its investigation.
