1. 12 bottle of Himalayan Gold country Spirit 600 ml, India Made Liquor and marked as Exhibit-

I am submitting a written complaint against the above noted accused personto the effect that today 12.08.25 at 11.05 hrs. I received source information that one person was carrying and selling ID Liquor illegallyat main road of DS Colony under NJP PS to its customers without any valid license. Accordingly I informed the matter to the duty officer of NJP PS and I.C. NJP PS and as per his instruction myself along with, C/1462 Sajan Tamang, VP-13 Jamirul Islam, VP-08 all of NJP PS, SPC left formain road of DS Colony to verify the veracity of information vide NJP PS GDE No.582 Dated- 12.08.25. On arrival at the spot on 12.08.25 at 11.45 hrs. it was found that one person mentioned above was selling liquor illegally at main road of DS Colony to his designated customers to earn huge money for his livelihood . On seen the police party the customers as well as seller tried to flee away, but the seller was apprehended by police, on being asked he disclosed his name and address mentioned above and also confessed that he is selling Id Liquor illegally to his designated customers without any license. Thereafter in presence of witnesses | recovered 1) 12 bottle of Himalayan Gold country Spirit 600 ml, India Made Liquor from his possession and seized the same as per proper seizure List and labeled duly signed by him and also witnesses. On being asked he failed to produce any document or license for selling the liquor. As such I arrested the above noted accused person u/s 35 BNSS as It's a violation under Bengal Excise Act. The seizure & arrest was made on 12.08.25 in between 12.03 hrs to 12.30 hrs. (seizure Total approx 7.2 Liters).

Therefore, I request you to start a specific case under the proper section of law against one arrested person namely Mahesh Roy (40/M) s/o Lt Jaharlal Roy of Jabravita, PS New Jalpaiguri Dist. Jalpaiguri and arrange for its investigation.
