Sir,

In producing herewith following one (01) accused person namely Surjo Roy (23/M) s/o Rajen Roy of Shantipara, PS New Jalpaiguri, Dist Jalpaiguri under arrest and One improvised fire arms measuring length 09 inch out of which 05 inches barrel, 02 inches body 02 inches butt and fitted with trigger and mark as Exhibit "A" and One piece of live ammunition mark as Exhibit "B".

I, SI, Tanmay Kundu of NJP PS, SPC do hereby lodged this written complaint against one arrested accused person namely Surjo Roy (23/M) s/o Rajen Roy of Shantipara, PS New Jalpaiguri, Dist Jalpaiguri.

In this regard, I beg to report that today i.e. on 12.08.25 at 22.15 hrs, I received a specific secret information that one person namely Surjo Roy had been coming from lake town towards New Jalpaiguri Station area for committing heinous crime under PS- NJP, Dist- Jalpaiguri. Accordingly, I diarized the information in General diary vide NJP PS GDE No 621 dated 12.08.25 and informed the fact to you. As per your kind order and direction myself along with ASI Manoj Majumdar C/1462 Sajan Tamang VP 13 Jamirul Islam all of NJP PS left for more bazaar side under PS-NJP, with investigation kit to work out the information by Govt. vehicle having no WB 77 4092 to verify the veracity of the information. Under such urgent circumstances any search warrant or authorization for search could not be obtained for want of time. So we had to move fast without affording the miscreant the opportunity for the concealment of evidence or facility for his escape. At 22.30 hrs we arrived at More bazaar area under NJP PS and as indicated by the source we noticed that one person was coming from lake town side towards more Njp station area. After seeing him we try to stop them but on seeing police personnel approaching towards him, he tried to flee away from the spot but on hot chase we managed to stop them. On interrogation, he disclosed his identity as noted above. As per source information, he has possessed 01 improvised small Fire arm, hence, immediately we searched him and recovered One iron made improvised fire arms having length approx nine inches fitted with trigger and One live ammunition which was kept concealed in the waist under the shirt of Bivas Dutta. The accused person namely Surjo Roy possessed improvised Fire arm and total one live ammunition illegally. On demand he failed to produce any document in support of the said improvised Fire arm and one live ammunitions which was found from his exclusive possession. Thus, his involvement in carrying and possessing illegal Fire arm and ammunition was established, Then I seized the said iron made improvised fire arms having length approx nine inches fitted with trigger and marked as "Exhibit A" and One live ammunition and marked as "Exhibit-B under proper seizure list duly signed by the witness namely 1)Papon Das s/o Khokon Das of

Kawakhali, Sushrat Nagar PS Matigara Dist Darjeeling and acknowledge by the accused person. The search, seizure and label were made in between 22:55 to 23:10 hrs and subsequently I arrested them by preparing memo of arrest and informing him the ground of arrest.

Under the above noted facts and seizure of incriminating articles, there is strong reason to believe that the said accused person namely Surjo Roy (23/M) s/o Rajen Roy of Shantipara, PS New Jalpaiguri, Dist Jalpaiguri is desperate and dangerous in nature, and they were carrying the said Fire arm ammunitions with an ill motive to commit heinous crime in the locality. As they willfully violated the regulation of Arms Act, 1, therefore, I pray before your good self that a specific case may kindly be initiated against the accused person namely Surjo Roy (23/M) s/o Rajen Roy of Shantipara, PS New Jalpaiguri, Dist Jalpaiguri under proper section of law and its investigation may kindly be arranged.
