I, **NAVIN SHARMA**, Son of Brij Kishore Sharma, resident of Ganga Nagar, Ward no. 5, Siliguri Municipal Corporation, Post Office - Siliguri, and Police Station - Siliguri, District - Darjeeling, Pin - 734005 would like to lodge a written complaint against the above named miscreant to the effects as follows:-

1. Sir, on 12.08.2025 at around 5.30 PM, the above-named miscreant namely **Durga Nand Mishra** along with his associate namely **Vivek Singh** came to my shop situated at Anjani Apartment Block - F, Ward No.5, Post office & Police Station:- Siliguri, District: Darjeeling, Pin: 734005 and suddenly started abusing me with obscene and filthy languages and when I protested said **Durga Nand Mishra** physically assaulted me with fists and blows and suddenly gave a severe punch over my face causing my nosebleed.

2. That immediately thereafter said miscreant **Durga Nand Mishra** lifted me and violently threw me on floor resulting in severe injuries to my back bone and head and further taking advantage of the situation both of them with the intention to cause my death, repeatedly kicked private parts of my body which caused me grievous injuries and **Durga Nand Mishra** further strangled me neck and snatched away my gold chain of 12 grams.

3. That immediately thereafter my well-wishers took me to Siliguri Public Hospital wherein I am admitted and my medical treatment is going on. Sir, due to my admission in Siliguri Civil Hospital I am unable to appear before your good police station and as such I am submitting my complaint through my friend named **Varun Agarwal** Son of **Ravikant Agarwal** of Santoshi Nagar, Siliguri, Darjeeling.
