With due regard and humble Submission I Vijay Kumar Sharma
Son of late M.L. Sharma, resident of Agarsen Road, Khalpara, Ward No-9, P.O &
P.S- Siliguri, Dist- Darjeeling do hereby submit the following for our kind
consideration and legal action:-

1. That yesterday on 13/08/2025 at about 8:30 I along with my Sons were having dinner all of sudden Vicky @ Bikash Sharma entered into my room and started to abuse me in filthy language and when my son namely Madan Mohan Sharma and others Sons protested then all the above named person came into my room and sated physically assaulting me my sons mercilessly with Fist & blow and Vicky @ Bikash Sharma brought a Iron rod and started to hit upon my son namely Madan Mohan Sharma and he sustained injuries upon his body and Smt. Pushpa Devi instead to settle the matter she was provoking her husband and her sons to hit and to kill .
2. That Lilu @ Niten Sharma and Kalicharan Sharma got hold of Madan Mohan Sharma and Vicky @ Bikash Sharma snatched Rs. 15,000/- from my son said son by using criminal force against him in a illegal manner.
3. That the above named person tore my wearing apparences and they threaten me and my son to leave the house immediately otherwise they will kill all the family members.
4. That I and my son reported the matter to the Police but they refused to take any legal steps at Night.
5. That on 14/08/2025 I took my said son namely Madan Mohan Sharma to Siliguri District Hospital for treatments as he was crying with Pain.
6. That earlier on several times I have lodged Complain against the above named person but till date did not received any fruitful result and for the same they are assaulting/threatening & abusing in filthy language to me & my other family members.
7. That the above named person are always threatening & abusing in filthy language and always kept violence with me and my sons intentionally in order to drag me & my other family members from the Building as a Civil Suit being Suit No- 43/2017 for Partition of the property is pending before the Court of Ld. Civil Judge Senior Division at Siliguri.
8. That today in the morning the above named person in an illegal manner by using Criminal force broke the lock of my Garage and they entered into the said Garage unlawfully and took out my vehicles which was kept in the said Garage and have thrown out of the said garage forcefully and started digging my said Garage in order to evict me from my said Garage forcefully and in an illegal manner and to take the possession of the said Garage in and forcefully and in an illegal manner.
9. That on each and every day Jagdish Prasad Sharma and his sons/family members create Violence /dispute and harass me and my family members in numerous ways and they by parking Motor bike/ scooty in the common passage and block the common passage for which have to face problem for ingress and exit and if I or any of my family members raise objection then they become violent and Physically assault and quarrel with me.
