Sir,

I, Sri Rubul Talukdar, son of Jatindra Nath Talukdar working as Assistant General Manager at ICM Logistics Pvt. Ltd. having its office at Village- Dhorka, Sector 92, Pataudi Road, Wazirpur Chowk CNG Pump, Garhi Harsaru, Gurgaon- 122505, Haryana Would like to draw your kind attention to the fact that Macleods Pharmaceuticals Ltd. has booked consignment of medicine to be transported from Siliguri, Matigara to Vijayawada on 30.07.2025 with our company and our company handed over the said Consignment to RGFC Transport vide bilty no. 1006399 for delivery of the said medicines (506 boxes counted by the driver of the truck and duly acknowledged on the bilty copy) and the driver of the said truck left the delivery place after unloading the consignment without informing us and later upon receiving/counting of the said consignment by our customer at Vijayawada 29 boxes of the medicines/consignment were missing and to the effect I lodged a missing diary before your concern police station and the said missing diary was registered vide Matigara Police Station GD No. 347 dated 06.08.2025.

Subsequently when our company inquired the matter with the said owner of RGFC Transport and Amir Khan i.e the driver of the said Truck bearing no. HR55AW6581 they denied the allegation, did not gave satisfactory reply and avoided our question on various pretext and further stopped receiving our call.

So, in the above situation it is clear that the said truck owner and driver have taken out goods from the consignment and I request you to kindly take necessary action against the owner and driver of truck bearing no. HR55AW6581 for stealing the goods, breaching the contract and cheating as per law and help me recover the said medicines/consignment.
