Sir,

With due respect, I am producing herewith 01 (one) arrested accused person namely Hare Krishna Rai (28 yrs approx), S/O- Lt. Man Bahadur Rai of Balason Colony, PO- New Rangia, PS- Matigara, Dist- Darjeeling and Eight (08) bottles of Himalayan Gold 60 UP Country Spirit each bottle containing 600 ml and in total 4.8 Liter as seized articles. The ground of arrest duly been communicated with him.

I, ASI Pema Dorjee Sherpa, of Matigara PS, SPC under your kind control beg to state that on 12.08.2025 at around 19:56 hrs I received a secret source information that one person as noted above is selling liquor illegally from his in law house located at Sadhan More near Sacred heart School, PO- New Rangia, PS- Matigara, Dist- Darjeeling. Accordingly, myself along with ASI Chandra Prakash Adhikary, C/219 Sanatan Chitrakar and C/868 Sujal Roy all are of Matigara PS, SPC left for Sadhan More near Sacred heart School under Matigara PS to work out the information in hand. This refers to MTG PS GDE No. 655, Dt- 12.08.2025. At 20:10 hrs we arrived at Sadhan More near Sacred heart School at the house of Kaushlya Roy and as per indication by the source, I apprehended the above noted person in red hand who was selling liquor from his in law house. On being asked he disclosed his name and address as noted above. During interrogation he disclosed that he is selling liquor from his in law house located at Sadhan More near Sacred heart School, PO- New Rangia, PS- Matigara, Dist- Darjeeling for his illegal gain. On being search his house, the above noted liquor were recovered. On demand he failed to produce any documents/license in respect of store/sale of the liquor which were recovered from his house. Accordingly, I seized the above noted liquor which were found from his possession under proper seizure list and arrested him under proper memo of arrest and observing all the formalities. The whole process of search, seizure, label & arrest was made in between 20:15 hrs to 20:35 hrs on 12.08.2025 under videography. The video was done by C/219 Sanatan Chitrakar.

Under the above noted fact and circumstances, I, therefore, pray before your kind honour that a specific case under proper section of law may kindly be started against the arrested accused namely Hare Krishna Rai (28 yrs approx), S/O- Lt. Man Bahadur Rai of Balason Colony, PO- New Rangia, PS- Matigara, Dist- Darjeeling and arrange for its investigation.
