Sir,

In producing herewith one arrested accused person namely Roshan Barman-23yrs s/o Ramani Barman of Roy colony, Chayanpara, ward no-42, PS Bhaktinagar Dist Jalpaiguri along with the following seized articles under seizure as per seizure list:-

- (i) 36 (Thirty six) Bottles of ONEREEX Cough Syrup each bottle containing 100 ML and Composition with Chlorpheniramine Maleate 1P 4mg, Codeine phosphate IP 10 mg (Total weight 36pcs X100 ML=3600 ML = 3.6 Ltrs)
- (ii) One white colour big plastic sac (SL No-1 was kept in SL no-2)

I, SI Srimanta Chatterjee s/o Lt Debi Prasad Chatterjee of Bhaktinagar PS under Siliguri Police Commissionerate do hereby lodged this written complaint against above mentioned accused persons to the effect that on 14.08.25 at about 14.15 hrs, received a reliable source input that one male person was moving at Kamalanagar, Mahananda river near Shiv Mandir under Bhaktinagar PS with huge quantity of illegal cough syrup for delivering the same to his designed customers at Hill area for his wrongful gain. The matter was diarized in Bhaktinagar PS vide Bhaktinagar PS GDE No. 690 dated 14.08.25 and subsequently, I informed the matter in written to the I/C Bhaktinagar PS, SPC and being directed, at about 14.25 hrs myself along with SI Yuel Lepcha, ASI Dipak Karmakar, ASI Dhurbo Mishra, ASI Khagen Barman, Const/374 Debraj Biswas, all are Bhaktinagar PS with investigation kit left for Kamalanagar, under Bhaktinagar PS by govt vehicle to verify the veracity of the information also informed PS night van officer ASI Arjun Prasad Dhayani (K-37) to immediate attend at Kamalanagar. This refers to Bhaktinagar PS GDE no. 691 dated 14.08.25 and M.C.C No- 4054/25 Dated 14.08.25.

Under this circumstance any search warrant or authorization cannot be obtained without affording opportunity for the concealment of evidence or facility for the escape of the offender.

Thereafter at about 14.40 hrs we reached at Kamalanagar area near Shiv Mandir under Bhaktinagar PS and meanwhile called two independent witnesses namely; (1) Gobind Prasad @ Bhagat -27yrs s/o Gopal Prasad of Vivekanandanagar, ward no-42, PS Bhaktinagar Dist Jalpaiguri (ph-7063811045) and (2) Sonu Roy-35yrs s/o Chandradev Roy of Kamalanagar, near Shiv Mandir, ward no-42, PS Bhaktinagar Dist Jalpaiguri (Ph-8191964773) and disclosed our identity and informed them about the information in hand and requested them in writing to accompany us in the whole process during search and seizure, if any and they gave in writing about their approval to accompany Police during raid, search and seizure.

and seizure. After sometime waiting there and being accompanied by source and the witnesses our whole police party detained one male person at Kamalanagar, Mahananda River dam near Shiv Mandir. We disclosed our identity and the information in hand and stated him that he will be searched in person for the purpose. At this, he disclosed his name and address as noted above. On being asked he admitted that he had illegally possessed Cough syrup in his possession for selling the same to his designed customers as per requirement for his wrongful gain. He also stated that some cough syrup was kept in his white colour sac.

I then gave an option in writing whether he is willing to be searched in presence of an Executive Magistrate or Gazette Police Officer, on return he given in written reply that he is willing to be searched in presence of Gazette Police Officer. Then I informed over telephone to Shri Amit Adhikary, Inspector In-Charge, Bhaktinagar Police Station to come to Kamalanagar, Mahananda River near Shiv Mandir requested him to presence during search and seizure of the Cough syrup. Accordingly at 15.25 hrs Shri Amit Adhikary, Inspector In-Charge, Bhaktinagar Police Station arrived at the spot as Gazette Police Officer and subsequently, under his supervision in presence of witnesses the process of search of the detained person for conducted following all formalities and recovered the above noted articles from the possession of above noted accused person which was kept in hand. Subsequently, being demanded in presence of Shri Amit Adhikary, Inspector In-Charge, Gazetted Police Officer the detained person failed to produce any valid document in support of possessing of the cough syrup.

Thereafter, I recovered one white colour big sac containing with total 36 (Thirty six) bottles of ONEREEEX Cough Syrup each bottle containing 100 ML and Composition with Chlorpheniramine Maleate 1P 4mg, Codeine phosphate IP 10 mg (Total weight 36pcs X100 ML=3600 ML = 3.6 Ltrs) which was kept inside in above noted bag. Then, I seized the above noted articles at the spot under proper seizure list duly signed by the independent witnesses. I also labelled and sealed all the articles under the supervision of Shri Amit Adhikary, Inspector In-Charge of Bhaktinagar PS and witnesses and accused person. The whole process of search & seizure has been audio & VDO graphed. The whole process of seizure was made in between dated 14.08.25 at 15.35 hrs to 16.25hrs.

Being further asked, the apprehend person namely Roshan Barman-23yrs s/o Ramani Barman of Roy colony, Chayanpara, ward no-42, PS Bhaktinagar Dist Jalpaiguri admitted in presence of Shri Amit Adhikary, Inspector In-Charge of Bhaktinagar PS and other witnesses that he procured the cough syrup clandestinely from elsewhere for the purpose of selling the same in high rate to his designed customer of Hill side for his personal gain by illegal means. He also disclosed that he had been dealing in such business of procuring and selling of cough syrup illegally for last few months.

Then, I arrested the above noted accused person namely Roshan Barman-23yrs s/o Ramani Barman of Roy colony, Chayanpara, ward no-42, PS Bhaktinagar

Dist Jalpaiguri after observing all formalities and informing the ground of his arrest and issued necessary Memo of Arrest u/s 35 (3) of BNSS and ground of arrest in writing.

Under the above circumstances, I pray to you that a specific case under proper section of law may kindly be started against the accused person namely Roshan Barman-23yrs s/o Ramani Barman of Roy colony, Chayanpara, ward no-42, PS Bhaktinagar Dist Jalpaiguri and arrange for its investigation.
