Sir,

With due respect, I am producing herewith two (02) accused persons namely (1) Ani Paswan (18), S/O- Shekhar Paswan of Panda Para, PS- Kotwali, Dist- Jalpaiguri (driver of vehicle bearing Regd. No. WB 73 D 0331) and Sumit Sarkar (20), S/O- Shambhu Sarkar of Purba Altagram, PO- Magurkhali, PS- Dhupguri, Dist- Jalpaiguri (driver of vehicle bearing Regd. No. WB 71 A 8125) along with following articles/cattle under seizure;

- One White coloured Bolero Pick up vehicle bearing Regd. No. WB 73 D 0331 loaded with three (03) numbers of cow and three (03) numbers of calves (all Black in colour).
- 2. One White coloured Bolero Pick up vehicle bearing Regd. No. WB 71 A 8125 loaded with nine (09) numbers of Calves of Buffalo (all Black in colour).

I beg to report that today on 12.08.2025 at 18.05 hrs received source information that two numbers of vehicle having Regd. No. WB 73 D 0331 and WB 71 A 8125 are coming from Siliguri side towards Jalpaiguri via Bandhunagar under PS- Bhorer Alo carrying cattle illegally. Accordingly, I shared the information with O/C PS and as per his direction, I along with C/1492 Partha Chakraborty, C/322 Jayanta Roy, C/505 Tapash Dutta, C/393 Shyamal Roy and NVF/29 Kiran Roy left PS for Bandhunagar under Bhorer Alo PS at 18.15 hrs to verify the veracity of the information. This refers to Bhorer Alo PS GDE No. 429 Dated. 12.08.2025. After reaching at Bandhunagar we started keeping watch at the vehicle coming towards Jalpaiguri from Siliguri side. Subsequently, at around 18.55 hrs on 12.08.2025 the above noted vehicles arrived at Bandhunagar area under Bhorer Alo P.S. We stopped the said vehicles having Regd. No. WB 73 D 0331 and WB 71 A 8125 at Bandhunagar under Bhorer Alo PS and found the above noted persons inside the vehicles as mentioned above. Subsequently, on search following numbers of cattle found loaded on the vehicles noted below in immovable condition;

- (i) Three (03) number of Cows and three (03) number of Calves on vehicle bearing Regd. No. WB 73 D 0331,
- (ii) Nine (09) number of Buffalo Calves on vehicle bearing Regd. No. WB 71 A 8125.

Further, on interrogation the apprehended persons disclosed their identity as noted above and on demand failed to produce any valid documents with respect of the cattle loaded on their respective vehicle and they also failed to produce any veterinary Certificate and papers of the said vehicles. Further, being interrogated, they admitted that they were carrying the cattle illegally being procured in fraudulent means and were loaded from Siliguri side to dispose the same somewhere in Jalpaiguri. Subsequently, I seized all the above noted vehicles being loaded with cattle from their possessions after preparing proper seizure list duly signed by them and seizure witnesses.
