I Manoranjana Rai @ Burman, the above noted complainant beg to inform you that on dt. 15.08.2025 at about 10:30 am, when I was standing at Tappi more in search of Rajmishi work as usual at that time the above noted alleged persons namely (1) Babu Hussain (2) Parvin Bibi W/O Babu Hussain (3) Nour Bara Begum W/O Md. Subhan (4) Md. Subhan (5) Md. Gazir & (6) mother of Md. Gazir, all are of Tulsinagar, Khalibakhti, P.S.-Mahagan, Distt-Bidya along with many male and female persons who were unknown, restrained me and started abusing me in filthy language and when I protested they started beating me brutally with fist, blows & legs & with lathi, and surrounded my neck with gamachha (thin towel) and tried to kill me. They also surrounded my waist with gamachha (thin towel) and pushed me to a distance.

I received severe injury on my person and my right wrist has been fractured and spinal cord has been also cracked, this way they tried to kill me, and they also stolen away my mobile phone (Realme) loaded with sim card bearing contact No. 7679898859 (Jio) and also Rs. 500/- (Paper five hundred) only cash from me.

Sir I immediately shifted to Siliguri Distt. Hospital and took primary treatment and done X-ray of my wrist & spine. Sir it is pertinent to say that my adult son namely Raju Rai @ Burman (22) & Mehraroun Khatri (18 yrs) D/O Babu Hussain, both are adult and in love with each other & they have absconded together on dt. 10.08.2025 and were the cause, they taken law in their hands. So, please take necessary action against the above noted alleged persons.
