I Sri Kunal Yadav (Mob:62948-56116) son of Sri Suresh Ray, resident of Maharaj Colony, Near- Radha Krishna Mandir, Ward No. IV of S.M.C., P.O. & P.S. Siliguri, Dist. Darjeeling, would like to report you the following facts:-

1. That in the month of June, 2025 said (1) Vivek Gupta son of Ashok Gupta residing at Maharaj Colony, Opposite – Rishikul Public School, Ward No. IV of S.M.C., P.O. & P.S. Siliguri, Dist. Darjeeling came to me and told me that some personal financial crisis of money.

He convincingly told me that if I give Rs.2000/- (Rupees Two Thousand) to him then he will return me after 1 (One) month honestly, sincerely and faithfully, but till my money is remained of him.

2. Thereafter several times he came to me at my residence and insist me to give Rs.2000/- and on his such repeated request / approach and I agreed to give him Rs.2000/- with a hope that I will get return back my money after one month as he assured me.

But today at 11.00 A.M. I phoned him over mobile phone by saying that when will you return my aforesaid amount of Rs.2000/- to me? Then he said to me that come to my house then I went to his house during said time he (Vivek Gupta) and his brother, brother's wife and his mother namely (1) Vishal Gupta son of Ashok Gupta, (2) Smt. Madhu Gupta wife of Ashok Gupta and (3) Smt. Sangita Gupta wife of Vishal Gupta all are residing at Maharaj Colony, Opposite – Rishikul Public School, Ward No. IV of S.M.C., P.O. & P.S. Siliguri, Dist. Darjeeling, subsequently they brutally assaulted me by fists and blows and leather belt and also threatened me by

saying that " Nhi dega paisa Madarchod, Kya karega, tera aur tera family ko v marega, Police mera Pocket me hai." then any how I rescued myself from their hands and came my residential house and told the whole incident to my family members.

That today thereafter me and along with my family members went to his (Vivek Gupta) residential house at about 5.00 P.M. to 6.00 P.M. to ask why you all are brutally assaulted then they all abused us very filthy languages and assaulted me and also my father by fists and blows and Vivek Gupta and Vishal Gupta touched the body parts of my mother and my elder brother's wife with wrong intention and also threatened me with dire consiquencious that they will murder me and will throw my body from the outside of the city.

4. That due to such assault upon me and my aforesaid family members and due to their such attempt to murder me in such cruel manners, they sustained severe injuries on their persons and they were medically treated at Siliguri District Hospital, Siliguri, Dist. Darjeeling on 15.08.2025 at about 7.25 P.M.
5. That due to serious injury caused due to such assaulted by them upon my family members and me delay is caused for lodging this F.I.R. which may kindly be condoned.
6. That the Xerox copies of medical treatments papers are enclosed here with.

I therefore request you to kindly take necessary steps against the aforesaid culprits for the commission of the aforesaid offences upon my family members and me.
