Sir ,

I, Sri Pratik Malakar S/O late Prafulla Malakar of Dasarath Palli Market PO- Sevoke Road, PS - Bhaktinagar, Siliguri Police Commissionerate like to lodge this complaint against one Partho Das S/O Late Gopal Krishna Das of Bagpota Road, Sarsuna PS - Sarsuna PS Sarsuna Dist. - South 24 Parganas to the effect that I work as an Phlebotomist and the said Partho Das worked with me sometimes in 2022 to the end of 2024.

In 2022 , I handed him over one Oppo Reno mobile set bearing no 862661055435032 purchased in my name for use.

Again in 2024 , February I purchased one motor cycle of Bajaj make bearing no WB - 74BS2539(Engine no JA07AFP9A02357) (Chassis no MBLJAW216PgA02449) in my name and handed it over to him to facilitate his works as per his request.

But he eloped with both the items in the

month of July 2024. Before eloping he also took sixty thousand from me as loan for his mother's treatment.

Since then , I failed to contact and locate him as he is not answering my calls .

Meanwhile, I am getting notices of Kolkata police through flash messages of involvement of my bike in different MV Act cases.

Since ,he eloped with the items aforesaid, without my consent and getting involved in MV Act cases , it now appears to me he has done so with an criminal intent of misappropriation and I am apprehensive that he may use such misappropriated items in some criminal offence too.

I have since brought the information to your knowledge .

Kindly , register an FIR over this complaint and take steps to recover my misappropriated motor cycle and mobile set
