Dear Sir,

I, Md. Kalim Akhtar, son of Late Md. Jamil Akhtar, resident of Bibadi Sarani, Ward no. 35 of S.M.C., Bhaktinagar, P.S. New Jalpaiguri, District - Jalpaiguri, would like to state you that I and my cousin brother namely, Md. Saheer Akhtar, son of Sabbir Ahmed reside together in the afore said house having separate kitchens.

That my said cousin brother Md. Saheer Akhtar, who is a truck driver by profession and often comes to home late in the evening in an intoxicated condition and always behave rudely with all the members at home and sometimes also resort to scuffle, but he being a family member we generally ignore his such acts and activities.

I along with my wife were at Patna, Bihar to attend a wedding function. On 10.08.2025, my daughter Sabeeh Fatima called me over phone and informed me that my said cousin Md. Saheer Akhtar and his wife Mazebeen (Malka) were misbehaving with my old ailing mother namely, Smt. Gulshan Begam aged about 65 years and my daughter over the partition of our ancestral property. As she was crying badly, I consoled her and told her that I will come back from Patna the next day.

That thereafter, I along with my wife came back from Patna on 11.08.2025 and entered the house at 10:00 P.M and when my said cousin Md. Saheer Akhtar and his wife Mazebeen saw me, they came at us and started shouting at us without any rhyme and reason and said Md. Saheer Akhtar was in an intoxicated condition and was also not able to stand properly. I asked him to talk tomorrow as he was not in a condition to understand anything. After hearing this, he and his wife got infuriated and started abusing me and my wife with filthy languages which cannot be uttered in a civilized society. Thereafter, he pulled me by my collar and started kicking

me and punching me and when my wife came to save me, he pushed my wife on her chest and his wife Mazebeen also assaulted my wife by pulling her hair and dragging her. Further when, my daughter also came from inside, said Md. Saheer Akhtar ran at her with a 'batam' (wooden thick block) to beat her, he slipped and fell down. Later, he and his wife had threatened me that they will take control of the entire house and if I or my wife come in between then he and his wife will kill me.

Under the above circumstances, I would request you to kindly take appropriate legal steps against the said Md. Saheer Akhtar and Mazebeen (Malka) in the interest of justice.
