

With due respect, I am producing herewith one accused person namely Sofiquil Islam (35/M) s/o Lt Osman Ali of No 2 Panowari, PS- Gossaigaon, Dist. Kokrajhar, Assam , under arrest along with seized cattle and seized vehicle ;

1. Eighteen (18) numbers of Buffalo In Black colors and different sizes.
2. One Vehicle (Truck) having Registration No. BR-28GA-1786 which used to carry the seized Buffalo SL. No. 1.
3. One Driving License having No. AS-16-20110016263 in the name of Sofiquil Islam (35/M) s/o Lt Osman Ali of No 2 Panowari, PS- Gossaigaon, Dist. Kokrajhar, Assam , Issued by L.A.A Kokrajhar, Assam valid up to 09.05.2027.

I ,ASI Uttam Kundu Of New Jalpaiguri PS under Siliguri Police Commissionerate do here by lodged a written complaint against the above noted accused person (driver) to the effect that on 13/14.08.2025 myself along with force were performing morning mobile duty vide NJP PS GDE No. 676 dt. 13.08.2025 and on 14.08.2025 at 05.35 hrs. received a secret source information that some vehicles are being loaded with cows illegally coming towards Jalpaiguri side from Phansidewa side without any valid documents/papers and if immediate action is taken, it can be apprehend . Accordingly I shared the information to I/C PS and on duty officer of PS. Thereafter as per your direction myself along with NVF-108 Swadesh Roy , HG-1125 Jiban Roy left for Fulbari to verify the veracity of information which diarized vide New Jalpaiguri PS GDE No. 682 dt. 14.08.2025. At 06.05 hrs. We reached Fulbari Toll Plaza under New Jalpaiguri PS and Just after a few minutes on the basis of secret information we intercepted the one vehicle and apprehended the driver of the said vehicle having No. BR-28GA-1786. On checking the vehicle we found Eighteen (18) numbers of Buffalo in Black colors and sizes were loaded on the vehicle. On being asked the apprehended driver disclosed his name and address mentioned above and admitted him as driver of the said vehicle and also stated he was carrying the Buffalo in his vehicle from Bidhannagar side towards Assam for selling the same illegally. On being asked, he failed to produce any License/papers in support of carrying the said Buffalo in that vehicle and also failed to produce any papers/documents in respect of the said Buffalo. It is crystal clear and reason to believe that the above noted accused driver procured the said cattle by illegal means or by stolen means for dishonestly disposing of the same to earn huge money illegally. On further checking it was found that there was no arrangement made for food and water for the said Buffalo as per Govt. rules. Besides this there was no sufficient space for the Buffalo in that vehicle. The apprehended accused driver of the vehicle also failed to produce any papers/documents in support of the said vehicle. Accordingly I seized Eighteen (18) numbers of Buffalo in Black colors and different sizes and (ii) One Vehicle (Truck) having Registration No. BR-28GA-1786 which was used to carry the Buffalo (iii) One Driving License having No. WB-59-20180045140 in the.name of Sofiquil Islam (35/M) s/o Lt Osman Ali of No 2 Panowari, PS- Gossaigaon, Dist. Kokrajhar, Assam , as per proper seizure list duly signed by the witnesses and arrested the apprehended person u/s 35 BNSS. The whole process of seizure and arrest have been made in between 06.25 hrs to 07.05 hrs.

Under the above circumstances, I pray to you that a specific case may kindly be started against the above noted arrested driver namely Sofiquil Islam (35/M) s/o Lt Osman Ali of No 2 Panowari, PS- Gossaigaon, Dist. Kokrajhar, Assam, of the above noted seized vehicle having No. BR-28GA-1786 and others to arrange for its investigation.
