Respected Sir/Madam,

I, Vineeta Singh, am filing this First Information Report in a state of extreme mental devastation, social disgrace, and irreparable emotional torment, having suffered relentless, deliberate, calculated, and diabolical abuse at the hands of my husband, Shri Gaurav Raj. This complaint is not merely a narration of facts, but a cry for justice from a woman in uniform who has been

repeatedly raped, insulted, slandered, threatened, and violated in every imaginable way by a man who disguised himself as a husband but turned out to be a savage predator and a disgrace to human civility.

1. SADISTIC AND REPEATED DOMESTIC CRUELTY

From just 7–8 days after our marriage on 22.04.2022 at Radhika Palace, Agra, I began facing an unending nightmare of brutal violence, both physical and sexual. He slapped me, screamed vulgarities, denied me basic respect, and reduced my dignity to nothing. When I was 5 months pregnant, he assaulted me in front of his family—an act so revolting that even animals wouldn't subject their own to such savagery. He routinely used abusive slurs such as “randi,” “haraamzadi,” “BSF ki rakhail,” and accused me of sleeping around with my colleagues. This became a pattern—monthly outbursts of cruelty escalating in severity.

2. OBSCENE, PORNOGRAPHIC, AND CYBER-SEXUAL ABUSE

The accused has created and circulated intimate videos without my consent and shared audio recordings of himself moaning in simulated sexual acts. These disgraceful and perverted materials were sent to me on WhatsApp via Truecaller and fake profile calls believed to be operated by him. He also sent obscene, naked, and indecent images of himself, with the explicit intent to send these materials to my Commandant and subordinate officers. His stated goal was to malign me, sabotage my service record, and permanently annihilate my professional dignity and reputation. This is a war on my identity as a woman, a mother, and a government servant.

3. DEATH THREATS AND LIFE-ENDANGERING INTIMIDATION

He has explicitly threatened my life with chilling words: “Tere goli maar dunga aur body bhi nahi milegi,” and “Tere office mein ghus ke tujhe nanga kar dunga.” These were not empty words. He stalked me, invaded my workplace, and created a security hazard within BSF quarters. He has also said, “Main teri beti ko utha le jaunga”—a monstrous threat to a 2.5-year-old child. This is not only criminal intimidation—it's attempted psychological murder. He
