Subject: Filing of Complaint Against Employees and Agents of Sundaram Finance for Illegal Seizure and Extortion

Respected Sir/Madam,

I, Arjun Rai, son of Birkha Bahadur Rai, resident of Sadam, South Sikkim, Melli – 737128, am the lawful owner of a vehicle bearing registration number SK05D0217. I wish to lodge a formal complaint regarding an incident involving the forcible and illegal repossession of my vehicle, criminal intimidation, extortion, and theft.

That in the month of March 2025, while I had parked my said vehicle at Fulbari to have lunch, a group of unknown men, agents and representatives of Sundaram Finance, including their manager, forcibly took possession of my vehicle without issuing any prior notice or intimation. At the time of the incident, I was harassed publicly on the road, physically threatened, and abused with filthy language. These individuals used muscle power to intimidate and overpower me, despite my protest.

I wish to clearly state that there was no outstanding loan pending with Sundaram Finance against the said vehicle at the time of this illegal act. The loan amount had already been cleared in full.

After the incident, when I attempted to contact the Manager of Sundaram Finance, instead of providing any lawful explanation or location of my vehicle, he demanded an illegal sum of money in exchange for the release of my vehicle. He also refused to disclose the location where the vehicle was taken.

Furthermore, at the time of the forceful repossession, there was approximately ₹25,000/- in cash inside the vehicle, which has also gone missing. I have not been provided with any receipt, documentation, or acknowledgment regarding the seizure of the vehicle or the cash therein.

The above actions constitute grave offences including theft, extortion, criminal intimidation, illegal confinement of property, and cheating, and they have caused me immense mental agony and financial loss.

I therefore request you to kindly: Register an FIR against the concerned agents, manager, and officers of Sundaram Finance. Raju Roy and Others, Take immediate steps to trace and recover my vehicle bearing registration number SK05D0217, initiate criminal proceedings against the persons involved for offences under the relevant sections of the Bharatiya Nyaya Sanhita, 2023 and other applicable laws, Ensure the recovery of my ₹25,000/- in cash or take appropriate legal action

I am ready to cooperate fully with the investigation and provide any additional information or documents required.
