Sir,

In producing herewith the 01 (one) arrested accused person namely Akhtar Ali (33 Walgara Station Kashem of Biswas Colony, near Rail Gate, PO+PS- Matigara, Dist- Darjeeling along with the Commissionerate seized article under proper seizure list:-

(i) 267 (Two hundred and sixty seven) grams suspected to be brown sugar containing in a white colour plastic zip packet and marked as 'Exhibit- A'.

(ii) One Adhar card in the name of Akhtar Ali vide No. 411763247017.

iii) INR-45,000/- (forty five thousand) Rs- 100*200 = 20,000/- and Rs- 500*50 = 25,000/-

I, SI Shib Sankar Das, of Matigara Police Station, Siliguri Police Commissionerate do here by lodge this written complaint to the effect that on 16.08.2025 at about 12:10 hrs, received a specific information provided by a credible source that 01 (one) person is standing at Biswas Colony near a grocery shop under Matigara PS with huge quantity of illegal suspected to be Brown Sugar for dealing.

Hence, there was a strong reason to believe that there is every chance of committing a cognizable offence under NDPS Act and to check the veracity of information, I reduced the information in writing vide Matigara PS GDE No. 852, Dated 16.08.2025 and I intimated the information to Shri Arindam Bhattacharjee, I/C Matigara PS, SPC who brought the information to the superior and after obtaining necessary order at about 12:25 hrs myself, along with a team of Matigara PS, SPC consisting of ASI Pema Dorjee Sherpa, ASI Chandra Prakash Adhikary, ASI Bikash Roy, C/219 Sanatan Chitrakar, C/868 Sujal Roy, all are of Matigara PS, SPC took departure vide C.C. No- 2461/25 dated 16.08.2025 from Matigara PS, SPC for Biswas Colony under Matigara PS with investigation kit containing envelope, white paper, sealing wax, gum, seal, digital weighing machine and other investigation kits by a Govt. vehicle to work out the information and the same was diarized vide Matigara PS GDE No. 853, dated- 16.08.2025.

At the same time I also informed the videographer namely Somnath Chatarjee, S/O- Sushil Chatarjee of Aurobindo Pally, Gokhel Road, W/No. 22, PS- Siliguri, Dist- Darjeeling to be present at Biswas Colony under Matigara PS, SPC to prepare the video of whole process of search and seizure if any. On 16.08.2025 at about 12:30 hrs, we reached at the Biswas Colony rail gate near Tazia under Matigara PS and I met with my source and he briefed me about the detail information and told me that the suspected person is standing in front of a grocery shop at Biswas Colony. Before that I looked up for public witnesses to the entire process of search and seizure. I found so many people but two of them gave their willingness to act as independent witnesses. The particulars of the witnesses are as follows 1] Md. Tasiruddin (38 yrs), S/O- Lt. Md. Tamijudin of Biswas Colony near Rail gate, PO+ PS- Matigara, Dist- Darjeeling, and 2] Md. Alam @ Dilip (55 yrs), S/O- Lt. Md. Idris of Biswas Colony near Rail gate, PO+ PS- Matigara, Dist- Darjeeling, and I briefed them about the information we had and requested them to stand as witness, who agreed to be stand as witness during the process of search and seizure and other process thereafter and issued notices to them. We parked our vehicle at near Tazia and we proceeding towards the suspected person.

In the meanwhile, I/C, Matigara PS sent a message to SDO, Siliguri to depute an Executive Magistrate during search & seizure of NDPS substances as per norms vide ORG No. 2575/25, Dated-16.08.2025. But after a telephonic conversation, it came to know that due to engage in other duty and short notice, there are no Executive Magistrate available to perform the duty.

In the above circumstances and the gravity of the information, if any delay occurred, the accused person may escape. Hence, as per order of superior, I/C, Matigara PS directed Shri Sajal Roy, Inspector of Police, Officer in Charge of NBMC OP under Matigara PS, SPC to be present at the place of occurrence to supervise the search & seizure if any. Accordingly Shri Sajal Roy left for the place of occurrence.

At about 12:45 hrs, my source identified the suspected person who is standing near a grocery shop at Biswas Colony. After a hot chase we managed to apprehend the suspected person. I introduced myself and the raid team members as Police officers. I appraised him about the information in hand and started to examine him thoroughly. On interrogation he disclosed his name and address as mentioned above.

On interrogation the detained person confessed that he is possessing and carrying a huge quantity suspected to be Brown Sugar with him. As per provisions of section 50 of the NDPS Act, 1985 (as amended) I explained to the above noted detained person that he has the legal right to tender his personal search in front of an Executive Magistrate or a Gazetted Officer and the same was given to him in writing. In reply he wanted to be searched before any police officer. At about 13:45 hrs Shri Sajal Roy, O/C NBMC OP under Matigara PS in the rank of Inspector of Police arrived at the spot as a Gazetted Officer where I briefed him the information in a nutshell. Also introduced the witnesses as noted above.

On further interrogation, the detained person confessed in front of the Gazetted officer that he was in conscious possession of a huge quantity of Brown Sugar which was kept and concealed inside the left side pocket of his pant.

Thereafter, in presence of the Gazetted officer, and the two independent witnesses searched the detained person namely Akhtar Ali. During the search found one transparent plastic zip packet containing suspected to be brown sugar, one adhar card in the name of Akhtar Ali, and Rs- 45,000/- (Rs- 100*200 = 20,000/- and Rs- 500*50 = 25,000/-) from his possession.

On interrogation, he stated that he brought the suspected to be brown sugar from Kaliachak, On interrogation, he stated that he blooght Biswas Colony to deliver his designated customer.

Malda and standing in front of his grocery shop at Biswas Colony to deliver his designated customer. Maida and standing in from of his globely slide and possessing the huge quantity. Then, I asked him to produce the valid license/ documents for carrying and possessing the huge quantity of illegal narcotics contraband articles but he failed to produce any legal papers.

After weighting the transparent plastic packet which was found in the possession of the detained person is weighted 267 (two hundred and sixty seven) grams. Thus, a reasonable belief having been formed that an offence has been committed in contravention of the NDPS Act and that recovered articles were liable to be confiscated by the NDPS Act. Accordingly, I had seized the above noted articles under proper seizure list duly prepared by me in presence of independent witnesses and Sri. Sajal Roy inspector of police, O/C NBMC OP under Matigara PS, Siliguri Police Commissionerate who acted as Gazetted officer. I also took signatures of the witnesses, the accused person and Gazetted officer and submitted my signature as seizing officer. Copy of the seizure list was given to the detained person.

Thereafter, 267 (two hundred and sixty seven) grams suspected to be Brown Sugar has been properly marked and labeled. Took signature of witnesses and accused person in the label in presence of the Gazetted officer.

I then arrested the above noted accused after informing him the grounds of arrest for the possession and carrying of contraband Narcotic drugs under the NDPS Act and issued an arrest memo to him accordingly, duly signed by the accused and witness.

The entire process of Search, seizure, Label, Seal and arrest were done in between 13:55 hrs to 14:20 hrs. The entire process of search, seizure, sealed and labeled were done under the supervision of Sri. Sajal Roy, Inspector of Police, O/C NBMC OP under Matigara PS, Siliguri Police Commissionerate acted as Gazetted officer and video graphed of search and seizure conducted through the camera of Somnath Chatarjee, S/O- Sushil Chatarjee of Aurobindo Pally, Gokhel Road, W/No. 22, PS- Siliguri, Dist-Darjeeling in compliance with the Order of Hon'ble High Court, Kolkata. The whole process of search and label was accompanied by the raid team members.

Under the above noted fact and circumstances you are requested to kindly lodge a FIR under proper section of law and arrange for its investigation against accused person namely Akhtar Ali (33 yrs), S/O- Md. Kashem of Biswas Colony, near Rail Gate, PO+PS- Matigara, Dist- Darjeeling and others involved in this racket.
