Sub THEFT INCIDENT COMMITTED BY BURGLES ON
INTERVENING NIGHT OF 11TH / 12TH AUG 2025 AND REQUEST
TO LODGE FIR THEREOF UNDER APPROPRIATE SECTION

1 Smt. Sharwani Sinha w/o Lala Krishna Kumar Lal, DIG presently serving at HQ Frontier BSF, Tripura, has been residing at Vivekanand Palli, Post Office- Kadamtala (Near BSF Frontier HQ (Street Opposite BSF Durga Mandir). PS-Matigara, Siliguri, Dist - Darjeeling.

2. On intervening night 11th / 12th Aug' 2025 a burglar entered into my house by jumping the main gate. Further, he entered inside house and opened the Almira and took some ornament (i.e Gold Neckless, earring & Rs. 10,000/-). Thereafter, he enter into the another room on the first floor, searched the Almira but he did not find any valuable items. Thereafter, he fled away by the jumping the main gate.

3. Besides, above, it is also come to the notice that after 20-25 minutes of the above incident he (burglar) again entered into neighbor house and it might to be recorded in the neighbour CCTV as well.

4. it is learnt that the burglar may be well known of area/ house as he is moving confidently in and around the house without any hesitation/ fear in both the houses.

5. In the light of above, I earnestly request you to investigate the matter thoroughly and apprehend the burglar at the earliest, so that such type of theft case can not be committed in future please.
