Respected Sir,

This is to report you that today, the 16th August, 2025 at around 10:00 AM., Tikaram Tirkey, son of Elias Tirkey, forcibly entered into the Manager's Bungalow from backside with a violent attitude. He was armed with a dangerous weapon, a long knife locally known as "Sikal or Daav" and attempted to attack the undersigned inside my Bungalow premises. During the incident, he used abusive language and continuously threatened to cause grievous harm to me and my family.

It was only with the intervention of two Bungalow servants that he was physically pulled out of the Bungalow, preventing further harm. Even then, he continued shouting threats, saying with pride that he had attacked before and that nothing would happen to him, claiming that no one could take any action against him.

In this connection, this is to mention that Tikaram Tirkey, being a repeated offender for the last 2 years, has been continuously coming to the Tea Estate Office, Bungalow, and other areas of the Tea Estate to threaten, intimidate, and create problems for the Manager and staff - for which FIRs had been lodged from time to time.

This repeated violent behavior of Tikaram Tirkey has been creating serious threat to the safety and security of the Managerial Personnel and staff and all of them are feeling extremely insecure to stay inside the Tea Estate along with their families and perform their day to day work.

In view of the foregoing I would request your good self to please look into the matter and initiate immediate action as deemed appropriate to prevent any further untoward incident and to save lives of the Managerial personnel.

Kindly treat this letter as an FIR.
