In producing herewith one arrested accused person namely 1) Anand lama (33 yrs) S/O Basan Lama of Nawab Ali Lane, Khidirpur PS Ikabalpur kolkotta West Bengal A/P Champasari Anchal Pravitra Nagar PS Pradhannagar Dist Darjeeling along with all connected papers.

I SI Kalipada Barman of Balasan Traffic Out Post Siliguri Police Commissionerate do hereby lodge this written complaint against the above noted arrested person named 1) Anand lama (33 yrs) S/O Basan Lama of Nawab Ali Lane, Khidirpur PS Ikabalpur kolkotta West Bengal A/P Champasari Anchal Pravitra Nagar PS Pradhannagar Dist Darjeeling to the effect that on 16/08/2025 during my special drunk and driving traffic naka checking at Balasan Colony under Matigara PS Dist Darjeeling vide Balasan Traffic Out Post MCC No. 643/2025, and GDE No. 91 dated 16/08/2025 myself, along with ASI Bijay Lama, ASI Sandip Dutta, ASI Md. Firoj, TC-837 Mihir Sarkar, LC-171 Dipa Gope, HG-1164 Subrata Singha were performing the said duty. During our naka checking at about 19.45 hrs the above noted person named Anand Lama s/o Basan Lama of Nawab Ali Lane, Khidirpur, PS-Ikbalpur, Kolkata, West Bengal 700023 was driving his scooty bearing no. WB 74 BR/2131 carelessly and recklessly where stopped by our officer and force at the Naka point and found that he is fully drunk after checked with breathe analyzer. On being asked by me about his whereabouts the said Anand lama used filthy languages and created nuisance and chaos in the public area and also obstructed our Govt. duty. I and other detailed officer at Naka point try to appeased him but he grab my uniform and assaulted me. Finding no any other alternative way I arrested him, maintaining proper memo of arrest and also communicated him the ground of his arrest in writing and also seized his Scooty bearing no. WB 74 BR/2131. The whole process of seizure, arrest were made in between 19.55hrs to 20.10hrs

Under the above facts and circumstances I pray before you that a specific case under proper section of law may kindly be started against the above noted accused person namely 1) Anand lama (33 yrs) S/O Basan Lama of Nawab Ali Lane, Khidirpur PS Ikabalpur kolkotta West Bengal A/P A/P Champasari Anchal Pravitra Nagar PS Pradhannagar Dist Darjeeling arrange for its investigation.
