I, **PRADIP KUMAR GHOSH**, son of Late Prafulla Kumar Ghosh, residing at Haiderpara Bazar, Sachitra Paul Sarani, P.O. Haiderpara, P.S. Bhaktinagar, District Jalpaiguri, would like to formally report that on **16th August 2025**, at approximately **8:30 AM**, an individual identified as **Sri Sanjib Chakraborty** unlawfully entered my business premises and committed theft.

I am the proprietor of a grocery store operating under the trade name "**Gopal Variety Store**", located at Haiderpara Main Road, P.O. Haiderpara, P.S. Bhaktinagar. On the aforementioned date and time, I briefly stepped out of my shop to attend to some personal matters at a nearby establishment. During my short absence, the said individual took advantage of the unattended premises, accessed the cash counter, and stole a sum of approximately **₹18,000/- (Rupees Eighteen Thousand only)** from the drawer and fled the scene.

Upon returning to the shop, I noticed the cash drawer was open and the cash was missing. I immediately reviewed the CCTV footage installed in my shop, which clearly captured the act of theft and identified the accused. From the footage, I was also able to ascertain the following details:

Therefore, found no other way came before your good office to immediate strict action to catch the person who stole my money and request you to recover my money as soon as possible.
