With reference to our discussion held at your Office on 06.06.2025 in connection with the subject as mentioned above, this is to bring to your kind notice as follows:-

1. That our Company is the owner of land in mouza Baraigach, JL no. 65 recorded in Khatian no. 7/1, Police Station – Bagdogra, district-Darjeeling and Mouza-Helakadam chat- JL No. 062, Khatian No-2, cultivating Tea in said land after obtaining permissions from the concerned Government authorities.

Have been trying to forcible encroach our Garden land at Section no.3 & 5 and we have lodged several FIRs on 27.03.2025, GDE No-1388 dt. 19/05/2025, GDE No- nil dt. 26/05/2025, GDE No.1257 & dt. 18/07/2025 GDE No-818.

That our Company had instituted a suit against them for declaration and perpetual injunction restraining them from entering into our Garden land and the said suit being numbered Title Suit no. 38 of 2017 was adjudicated before the Ld. Civil Judge (Junior Division) at Siliguri. The final order was passed in the said Suit on 09.12.2024, the relevant portions of said order are as follows:-
