Sir,

In producing herewith the female accused person named Smt. Chintamani Oraon, aged 40 years, w/o- Mohan Oraon, resident of Bhujipani Chhat, Dumriguri, PS- Bagdogra, Dist- Darjeeling (not verified) under custody along with following seized articles under proper seizure list:

1. Twenty (20) ltrs 'Chullu' in one plastic jar of 20 liters and marked as Exhibit-A.
 2. Twelve (12) bottles of "Himalayan Gold 60° UP India Made Liquor", each contains 600 ml @ Rs. 160/-, out of which 01 bottle is taken out as sample and marked as Exhibit-B.
- (Total 27.2 ltrs, total value Rs. 1920/-)

I, SI Binup Mahato of Bagdogra PS, S.P.C, Dist- Darjeeling, do hereby lodge this written complaint against the arrested female accused person named Smt. Chintamani Oraon, aged 40 yrs, w/o- Mohan Oraon, resident of Bhujipani Chhat, Dumriguri, PS- Bagdogra, Dist- Darjeeling to the effect that on 12.08.2025 at 15:10 hrs received reliable source information that a huge quantity of liquor is stored at the house cum shop of one suspect named Smt. Chintamani Oraon located at Bhujipani Chhat under Bagdogra PS and the same has been selling illegally from her house cum shop for her wrongful gain. Accordingly, I informed the matter to O/C Bagdogra PS and diarised the matter in GD vide Bagdogra PS GDE No. 534 dated 12.08.2025. Then as per direction of O/C Bagdogra PS, I along with SI Debabrata Kundu, C/1509 Sourav Roy Sarkar, LCV/98 Shilpa Karmakar, CV/389 Janak Singh & CV/375 Jogesh Barman left for Bhujipani Chhat under Bagdogra PS, SPC to work out the secret source information. This refers to Bagdogra PS GDE No. 535 dated 12.08.2025. Under these circumstances any search warrant or authorization cannot be obtained without affording opportunity for the concealment of evidences as well as for the escape of the offender. At around 15:30 hrs we reached at Bhujipani Chhat and being indication & identification by source we held raid at the house cum shop of the suspect Smt. Chintamani Oraon and managed to apprehend the suspect with the help of accompanying lady Police personnel and interrogated her. On interrogation, she revealed her identity as Smt. Chintamani Oraon, aged 40 years, w/o- Mohan Oraon, resident of Bhujipani Chhat, Dumriguri, PS- Bagdogra, Dist- Darjeeling who introduced herself as the owner of that house cum shop. We disclosed our identity to her and the input we had. We contacted with the local people to be present as witness during the process of search, seizure, if any. One tenant named Mery Munda, aged 40 years, w/o- Santosh Lohar, c/o- Smt. Chintamani Oraon, r/o- Bhujipani Chhat, PS- Bagdogra, Dist- Darjeeling, permanent address at Kamla bagan, Ghospukur, PS- Phansidewa, Dist- Darjeeling (Ph. No. 8927343175) was present there as independent witness. Then, we searched the house cum shop of the suspect Smt. Chintamani Oraon in presence of the independent witnesses as well as the Police personnel. On search, the above noted liquor was recovered from that house cum shop. On demand, she failed to produce any valid document/license for stocking, possessing & selling that liquor. She confessed that she had been stocking, possessing & selling liquor illegally from her house cum shop since long time for her wrongful gain. Her involvement is well transpired in this case. Accordingly, I seized that liquor (as noted above) under proper seizure list but the independent witness refused to sign on the seizure list. Accordingly, the seizure list was prepared in presence of Police witnesses and at last, I arrested the involved female accused Smt. Chintamani Oraon (as noted above) after observing all legal formalities and communicating her the ground of arrest in writing as she has committed a cognizable offence in presence of Police for stocking, possessing & selling that liquor illegally and issued memo of arrest in this regard. The process of search, seizure & arrest was made in between 15:33 hrs and 15:56 hrs on 12.08.2025 through audio-video electronic means using mobile phone and then the same audio-video record is converted to a pen drive using computer system.

Therefore, I request that a specific case under proper section of law may kindly be started against the arrested female accused person named Smt. Chintamani Oraon, aged 40 years, w/o- Mohan Oraon, resident of Bhujipani Chhat, Dumriguri, PS- Bagdogra, Dist- Darjeeling (not verified) and arrange for its investigation.
