Sir,

In producing herewith three apprehended accused persons named (i) Muskan Thapa (M/34 years), s/o- Uttam Thapa, (ii) Sanil Tamang (M/30 years), s/o- Kumar Tamang and (iii) Ashim Thapa (M/33 years), s/o- Uttam Kumar Thapa, all are resident of Potong T.E, Belagachhi, PS- Mirik, Dist- Darjeeling (not verified) under custody.

I, ASI Balaram Roy of Bagdogra PS, SPC, do hereby lodge this written complaint against the above noted three apprehended accused persons to the effect that today on 14.08.2025 in course of performing scheduled K-35 (I/III) mobile van duty under the jurisdiction of Bagdogra PS vides GDE No. 609 dated 13.08.2025 & e-Khaki MCC No. 2611 dated 13.08.2025 (Sl. No. 3434/25), I along with C/132 Pappu Limboo & CV/133 Kartick Das had been proceeding towards Tirupati Petrol Pump located at Gossainpur to refuel our Govt. vehicle No. WB77/4084. On the way to petrol pump, at around 00:15 hrs we noticed one person peeing on the main road (AH-02) near Uttora main entrance gate no.1. We descended from the vehicle and asked him why he had been peeing there. We saw that two others were standing nearby him. All on a sudden, other two also came there and all of them started to misbehave with us. We directed them to leave the place but they started abusing us by using filthy languages. Some passersby also informed them to leave the place. I asked their identity. On being asked they revealed their identity as noted above. Suddenly, said Sanil Tamang assaulted me over the right chest of C/132 Pappu Limboo. We became unable to control them as well the situation. Accordingly, I informed K-36 mobile officer ASI Jahangir Ali and PC mobile van officer ASI Munna Ahmed to come at the place. Then at around 00:40 hrs they reached at the place. Seeing more Police personnel, they furious and they started talking more aggressively. Having no other alternative, we decided to bring them to PS to avoid any untoward incident as well as to control the situation. But they denied going with us. When we tried to ascend them to our Govt. vehicle, all on a sudden said Sanil Tamang with the help of his other two friends assaulted ASI Munna Ahmed over his nose by fist and blows. As a result, ASI Munna Ahmed sustained injury and bleeding started from his nose. Thus, they deterred the public servants from discharge of their government duty. Then, we managed to bring them to Bagdogra Police Station after apprehending them u/s 35(1)(a) BNSS after observing all legal formalities and communicating them the ground of arrest as they have committed a cognizable offence in presence of Police Officers to prevent them from committing any further offence, to ensure their presence in the Ld. Court as well as for proper investigation of the case. Later, ASI Munna Ahmed and C/132 Pappu Limboo took medical treatment from Bagdogra PHC where the attending doctor referred them to NBMCH after conducting their primary treatment.

Under the above facts & circumstances, I request you to initiate a specific case under proper sections of law against the apprehended three accused persons named (i) Muskan Thapa (M/34 years), s/o- Uttam Thapa, (ii) Sanil Tamang (M/30 years), s/o- Kumar Tamang and (iii) Ashim Thapa (M/33 years), s/o- Uttam Kumar Thapa, all are resident of Potong T.E, Belagachhi, PS- Mirik, Dist- Darjeeling (not verified) and arrange for its investigation.
