Respected Sir,

With due respect I Smt. Gita Debi Gupta wife of Sri Jawahar Prasad, aged 56 yrs, resident of Tripali Jote -Baniakhari (opp. Aluminium Factory) P.O. Nema P.S. Matigara, Dist. Darjeeling. Pin-code-734010 west Bengal, would like to inform you that- I have constructed a Pucca residential house without any one assistance at land measuring 2 Kathas situated in Mouza- Baniakhari-, J.L. No.55, at Khaprail Road, P.S. Matigara, District- Darjeeling.-734010-West Bengal. In a family consent on the 15<sup>th</sup> November' 2024 I have given a shop room with residence rooms to my son Sri Jaydip Gupta, he is residing with his wife Smt. Komal Gupta and carry a business of Gift Items shop in my said house. They are living in separate mess and not look after us. My said son is in a Pvt. Job and his wife runs the Shop in front side of the house. At the time of their marriage I had given gold ornaments to the Smt Komal Gupta sum of Rs.5/6 Lac. They have kept with them.

That Sir, I had a Grocery Shop in the house having Trade License in front shop room, the said shop room had been illegally and forcefully captured by the culprits Jaydip Gupta and his Wife Smt. Komal Gupta, they sold my all grocery goods and open A Gift Item Shop in the said shop room forcefully. Thereafter said Sri Jaydip Gupta and his wife Smt. Komal Gupta have started different types of physical and mental torture upon us each and every times in our old aged and sicked. We are not physically able to bear such torture upon us by them. We have shut our mouth for the sake of social prestige in the society.

Sir, I have 3 sons and an unmarried daughter, all are engaged in their job. My 2 sons are out of state and country for their own business and my said unmarried daughter is also out of state for her job purpose but she is unmarried. When I asked my sons for financial assistance to give marriage of daughter but my son Jaydip Gupta and his wife Smt. Komal Gupta are not willing to assist though they have started quarrelling with dirty languages assaulted and threatened us to not further asked them for financial assistance.

That on **24-05-2025** when I was not at home in my room the above named culprits have illegally broken my door lock and forcefully entered furiously with intention to kill us by pressing neck and physically assaulted us as such we have sustained severe bodily pain and swelling on body and taken medicines. The nature, character and behavior of my son and his wife is very bad and dirty. So that we are feeling unsafe of our life in our house., They have gathered some anti social elements in the house/ room. They have also obstructed stir and bath room by keeping some their articles, so that we have feels unsecured and several troubles day to day.

That the above named culprits have most of the time threatened us with dire consequences and used abusive and slang languages upon us. They may have committed any offence/s with us at any time. We have many times tried to adjust with them and settled disputes amicably but in vein.

That on **18-07-2025** at morning about 8 AM said Jaydip Gupta and Smt Komal Gupta again assaulted me and tear my blouse, sari & hair and threatened to kill us and grab the property. Also used abusive and slang languages upon us. On same day I have gone to lodge complaint against them on same day but Matigara Police refused to take my complaint then I given a complaint to the Police Commissioner, SMP Siliguri. In the mean time my husband has file a case against them under Senior Citizen Act for evicting the house and maintain us but the above named Smt. Komal Gupta have lodged a false complaint on 29-07-2025 with Women P.S. Siliguri against all family members to illegally harassed us with the help of a relative of Siliguri & to sent us in jail with intention to compel us to give them all property. Again I came to know that the said culprits have lodged another complaint against us for theft illegally for that Matigara PC party and Police further came to inquire the complaint and also threatened us. At this age we are not bear such torture by the culprits upon us.

That I have repaired inner door of our room but on **11-08-2025** at about 8:30 PM the above named culprits suddenly attempted to broke the door and entered furiously into my room from outside with attempt to kill us in the room by Dau, knife and rod, on hue and cry by us the culprits fled away from my room and also threatened to kill us any day and grab the entire property. They have also thefted all my gold ornaments of Rs.2.5 Lac kept in the Almirah, and took some cash money all valuable security documents including all Tamba, Kansa, Petal utensil and other goods and valuable materials.

That the above named culprits are very dangerous persons bad in nature and character, having antisocial activities and highly influential person, who assist and entice them to commit the offence/s, harassed and kill us with illegal intention to grab the entire property alone. The culprits have always threat us to send us in jail in false case. They may have influenced any person to commit serious offence/s with us.

Therefore, I request you Sir, Please inquire the incidents and after inquiry please take necessary action against culprits as per law and save me and my husband and other family member's life from their hands.
